Questions and answers on the results of pre-bid conference, conducted on February 1, 2017 at UNDP office in Kyiv

Dear participants, please pay your attention once again to the following issues while bids submission:

1. Bids submission deadline – February, 10, 2017, 10:00 Kyiv time.

2. Bids submitting – electronic form to e-mail: tenders.ua@undp.org

3. Together with the documents set, the participant must submit electronic scan copy of the Bid security in the amount of 10 000 USD for the Bid on one or several Lots if the Total amount of the Bid is between USD 200,000.00 and USD 499 999,99 and in the amount of 25 000 USD if the Total amount of the Bid is more than USD 500,000.00

#	Question	Answer
1	Could we supply 2 different medicines from 2 different manufacturers for one Lot if their INN, dosage and presentation form are the same?	Yes, you can.
2	Could we propose the same medicine for Lot 1 "Coagulation factor VIII" as for the Lot 2 "Coagulation factor VIII and von Willebrand factor"?	Yes, you can provide the medicine with Coagulation factor VIII and von Willebrand factor for Lot 1 "Coagulation factor VIII"
3	Could we propose for Lots 9 and 10 "Human coagulation factor VIII (<u>plasma</u>)" the same medicine as for Lots 7 and 8 "Coagulation factor VIII (<u>recombinant</u>)"?	No, you can not.
4	There is a question regarding the term of validity of Bid Security. The validity of Bid Security is indicated as 150 days in p. 11 of "Data Sheet", and as 30 days in the Form of Bid Security in Section 9.	In the Form of Bid Security in Section 9 it is stated about 30 days <u>after the expiration of validity of Bid</u> itself. The term of validity of the Bid is 120 days, in accordance with p.8 of «Data Sheet". So, the term of validity of Bid security is 120+30=150 days.
5	Could we provide the Bid Security in UAH if the Bid is in USD?	 Preferably in USD but you can provide in UAH as well applying the internal UNDP FX rate on the day: of tender announcement - for Bid Security; of contract signing - for Performance Security.
6	Which documents should be provided in original, additionally to Bid Security?	No one. Only Bid Security.
7	How much time will we have to provide the Performance Security?	2 weeks.

8	Could we provide way bills instead of reference letters as the confirmation of previous supplies of product?	You are requested to provide reference letters
9	Could we provide only copies of contracts and not provide reference letters?	We ask you to provide reference letters as well.
10	What should we provide if we supplied goods to MOH but not directly to health care centers?	Please provide the letter/confirmation of contract from MOH. At the same time UNDP reserves the right to request the additional confirming information in future.
11	Should the Bidder put its visa and stamp on the Authorization Letter from manufacturer?	No, you should not. Authorization Letter should be signed and stamped only by manufacturer.
12	If the powder and reconstitution solution are produced on different manufacturing sites, should we provide GMP certificates for both sites or only one certificate for the site where powder is manufactured?	You have to provide GMP certificates for both sites.
13	What is the maximum term of delivery from the date of contract signing? You indicated 5 months in English version and 4 months in Russian version.	5 months. As it is indicated in the text of the document, the English version prevails. The Russian version will be duly amended.
14	What quantity of parcels of cargo is allowed in line with delivery terms? You indicated 3 in English version and 5 in Russian version.	3 (three). As it is indicated in the text of the document, the English version prevails. The Russian version will be duly amended.
