To provide the information about company and its experience, you could submit reference letters from partners/ distributors. To provide the information regarding the medicine, you need to submit reference letter from
		representative of health care center.
10	Is the reference letter from health care center enough or it is also necessary to provide the copy of contract for supply of quoted medicine?	The reference letter from health care center is enough. However, UNDP may additionally require the copy of contract, if necessary.
11	Regarding financial accountability: if the data for 2016 is unavailable yet, for what years should we submit the documents?	Financial documents for years 2014-2015 and for 9 month of year 2016 are needed.
12	Is an analogous contract for supply of similar medicine is obligatory requirement? What if a Bidder had supplied another medicine?	UNDP requires an analogous contract for the supply of the similar medicine that Bidder is offering for certain lot, however, the Bidder is not necessarily should be a holder of such contract. Please note that scope of supply of the similar product / medicine should be as close as possible to the requested quantity.
13	What is the procedure of Bid security (Bank guarantee) return?	The original of Bid Security will be returned to Bidders after signing the contract with the winner of tender. The winner will receive Bid Security after submission of Performance security if it is required by terms and conditions of the tender.
14	What kind of personnel is best to mention in Section 7: Technical Bid Form, Subsection 3.3: Personnel?	Only CV of representative who will be a direct coordinator communicating with UNDP on this contract is required.
15	Should we provide copies of documents on carrier vehicles used for transportation of medicines?	No, you should not. Provide general info in the Technical Bid Form.
16	Should we submit Certificates of Analysis, since some of the quoted products are not manufactured?	No, Certificates of Analysis on products are submitted before shipment, so you should not submit them on tender.
17	Could we submit the brief information (leaflet) from monography on the product as a requested Instruction but not the whole monography designed for specialists and consisting of 50 pages?	Yes, you can, but if possible please submit the whole monography
18	How important is to submit the List of shareholders and other persons financially interested in the company?	This requirement is obligatory for companies with just several shareholders who have more than 5% of shares but not for corporates

19	Where should we indicate the currency of our financial proposal?	You can indicate the currency in the table with proposal (in the name of the column for prices or in line with the Total amount) or in a separate sentence below the table
20	Should we sign and stamp other documents except for those filled in Sections 4-8?	No
21	What should we indicate in the column "Reference" in Section 4?	Please indicate the name of the document, page number where the referred information is contained in submitted Bid
22	Section 7, p. 1.3. Should the Bidder indicate all the contracts he has?	No, Bidder should indicate only several significant contracts.
23	We, as a manufacturer, made donations and received appropriate references, could we submit these references as well?	Yes, you can
24	Could it be that the foreign manufacturer acts as a Bidder to the tender with its several products but in case he wins the contract will be signed with him only for some of the proposed products and with his representative office - Ukrainian legal entity for the rest products (already present in Ukraine). The matter is that some products from the list are requested in low quantity for which it is not expedient to manufacture new batch in order to import them from abroad if they are already in Ukraine. We understand that there would not be VAT exemption for products which are already in Ukraine.	No. In such a case both the manufacturer (for positions to be imported from abroad) and the local representative/distributor (for items that are already in Ukraine) shall participate.
