1. Party A, the manufacturer, as the leading party, our company as the member.
2. Both parties will furnish relevant documents as stipulated in item 26/C.15.1 (page 20)? Or only the leading entity will do? Or some offered by the leading entity, and some by the member entity? **Both parties.**
3. In such a case, it is acceptable with you if the member entity furnish Performance Security? **the performance security is furnished by the lead entity.**
4. For those documents in Chinese language, is it OK with you if we supply translated English version files together with Chinese version? **this is a mandatory requirement. If translated documents are not submitted your bid will not be rejected. See "Section 2: Instructions to Bidders, article C.13."** For example, Business license, Certificates, Audited Reports, and the like.
