A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared. The price proposal will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical component.

The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR).

Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e. $Sf = 1000 \times Fm / F$, in which Sf is the financial score, Fm is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%.

Submission obtaining the highest weighted points (technical points + financial points) will be selected.

Interview with the candidates may be held if deemed necessary.

1) GENERAL BACKGROUND

The UN-REDD Viet Nam Phase II Programme is a part of the United Nations Collaborative initiative on Reducing Emissions from Deforestation and forest Degradation (UN-REDD). The Vietnam Administration of Forestry (VNFOREST) under the Ministry of Agriculture and Rural Development (MARD) is the Programme Owner. The Phase II Programme runs from mid-2013 to end-2018 and benefits from the support of the Food and Agriculture Organization of the United Nations (FAO), the United Nations Development Programme (UNDP) and the United Nations Environment Programme (UNEP).

Phase II of the Programme will assist Viet Nam to implement the National REDD+ Action Programme (NRAP). The overall objective is "to enhance Viet Nam's ability to benefit from future results-based payments (RBPs)¹ for REDD+ and undertake transformational changes in the forestry sector". This Objective will be secured through the following six Outcomes:

Outcome 1: Capacities for an operational National REDD+ Action Programme (NRAP) are in place

Outcome 2: The six pilot provinces are enabled to plan and implement REDD+ actions

Outcome 3: National Forest Monitoring System (NFMS) for Monitoring and Measurement, Reporting and Verification and National REDD+ Information System (NRIS) on Safeguards are operational

Outcome 4: Stakeholders at different levels are able to receive positive incentives

Outcome 5: Mechanisms to address the social and environmental safeguards under the Cancun Agreement are established

Outcome 6: Regional cooperation enhances progress on REDD+ implementation in the Lower Mekong Sub-Region

VNFOREST has established the UN-REDD Programme Management Unit (PMU) to implement the Phase II Programme under the leadership of the National Programme Director (NPD), assisted by a deputy NPD, and a National Programme Coordinator.

The six pilot provinces are: Lam Dong, Bac Kan, Ha Tinh, Binh Thuan, Ca Mau and Lao Cai. In these provinces, the Phase II Programme will support preparation and initial implementation of Provincial REDD+ Action Plans (PRAP).

2) BACKGROUND TO THE ASSIGNMENT

UNFCCC requirements on REDD+ safeguards:

The Cancun Agreements² (Decision 1/CP. 16), of the United Nations Framework Convention on Climate Change (UNFCCC), calls countries who will implement REDD+ to address and respect seven broad safeguards related to governance, social and environmental risks and benefits, as well as emission reductions risks. In addition, the Durban Outcome³ (Decision 12/CP.17) states that a safeguards information system (SIS) should provide information on how all Cancun safeguards are addressed and respected. This was reiterated by the Warsaw Framework⁴ for REDD+ (Decision 9/CP.19), that requires countries to submit, among others, summary of information on how all the safeguards have been addressed and respected before they can access result-based payments (RBPs).

Developing countries seeking to receive RBPs for REDD+ should provide the most recent summary of safeguards information, to be made publically available, upon commencing implementation of REDD+ actions. Once the first summary of information has been submitted, the frequency of subsequent summaries should be consistent with the provisions for submissions of national communications, i.e. at least once every four years for developing countriesⁱ. Additionally, a country may submit a summary of information directly to the <u>UNFCCC REDD+ web platform</u>ⁱⁱ at any time. There is no UNFCCC-required *structure* for a country's summary of safeguards information. Guidance on the *content* of summaries of information, however, has been adopted by CoP21⁵.

Country approach to safeguards: The UN-REDD Programme promotes <u>a country approach to safeguards</u>, which builds on a country's *existing* governance arrangements to meet UNFCCC requirements (see Figure 1).

These governance arrangements can be broken down into three core components:

1. Policies, laws and regulations (PLRs), which define, on paper, what needs to be done in order to support implementation of REDD+ actions in a manner consistent with Cancun (and other) safeguards, i.e. how safeguards are being addressed. PLRs are primarily codified statutory ordinance, but countries may also consider to include corporate environmental and social responsibility policies, industry standards and customary norms of ethnic minority peoples and local communities.

- 2. Institutional arrangements their mandates, procedures and capacities to ensure that the relevant PLRs are actually implemented in practice, i.e. how safeguards are being respected. Such arrangements are typically institutionalised within public, private or civil society sectors, but may also involve arrangements to strengthen the individual capacities of citizens, including ethnic minority peoples and local communities, to implement and enforce relevant PLRs.
- **3.** *Information systems*, which collect and make available information on how REDD+ safeguards are being addressed and respected throughout REDD+ implementation.

In addition to responding to UNFCCC requirements, a country approach to safeguards allows countries to consider further objectives, such as their own domestic sustainable development and green growth policy goals, other international policy commitments, as well as responding to the requirements of organizations providing interim results-based payments for REDD+ activities.

Country safeguard approaches can build extensively on existing national PLRs, government and non-government institutions to implement these PLRs, as well as systems for collecting and reporting information. **Safeguards work in Viet Nam:** Previous work on REDD+ safeguards was led by VRO/DOSTIC as focal point for REDD+ in Viet Nam. The sub-technical working group on safeguards (STWG-SG) was established in 2012 as platform for discussion and broad national level consultations (documentation can be found in http://www.vietnam-redd.org/Web/Default.aspx?tab=news&zoneid=108&subzone=113&child=209&lang=en-US).

Until end of 2015, the major piece of work on REDD+ safeguards has been the development of a 'Safeguards Roadmap' for the NRAP, which outlined the country-led approach to REDD+ safeguards. The roadmap also included a review of existing PLRs which demonstrate on paper how Viet Nam could address the Cancun safeguards (see green boxes in Figure 1 above) and identified corresponding gaps in the existing PLR framework against a generic international legal best practice interpretation of the Cancun safeguards.

Subsequent to this initial PLR assessment, in 2016, the UN-REDD Viet Nam National Programme Phase II has instigated two parallel assignments making significant contributions to the country's approach to safeguards: 1) an initial assessment of institutional capacities to implement priority PLRs (see blue boxes in Figure 1 above); and 2) a consultative, multi-stakeholder SIS design process (see purple boxes in Figure 1 above).

In addition to these UN-REDD assignments on safeguards, the World Bank-administered Forest Carbon Partnership Facility (FCPF) has conducted a Strategic Environmental and Social Assessment (SESA) focusing on Viet Nam's proposed Emissions Reduction Program for the FCPF- Carbon Fund in the North-Central Agro-Ecological zone. The SESA process will culminate in the development of an Environmental and Social Management Framework (ESMF) for this proposed Emissions Reduction Program landscape.

Safeguards under UN-REDD Programme (Outcome 5): The core focal areas of Programme support under Outcome 5 are: (1) goal, scope and process of country safeguards approach defined and safeguards information system (SIS) determined and (2) policies and measures to ensure that safeguards concerns are being addressed and respected.

3) OBJECTIVE & SCOPE OF THE ASSIGNMENT

The key objectives of this assignment is to assist VNFOREST-VRO in:

- 1) refine the design and operationalise the SIS v1.0, building on the draft Technical Proposal for the Development of a SIS in Viet Nam prepared by VNFOREST-VRO; and
- 2) formulation of Viet Nam's first summary of information (SoI) on REDD+ safeguards through identifying, compiling and structuring relevant information in accordance with UNFCCC guidance.

To achieve the objective, this assignment intends to complete the following five steps in the following order (detailed tasks under each step are given in Section 4):

PREPARATION

STEP A. Work and stakeholder consultation planning

SIS

STEP B. Developing the SIS database

STEP C. Developing national and provincial safeguards information reporting templates

STEP D. Institutionalising functional responsibilities for SIS operations

Summary of information

STEP E. Drafting first summary of information (Sol)

A consultant team will be mobilised to assist through-out the process of operationalising Safeguards Information System (SIS) and preparing Viet Nam's first REDD+ safeguards summary of information (SoI). To complete the assignment, it will be necessary to draw, as much as practically possible, on other major safeguards assessments recently completed, or being conducted in parallel to this one, notably:

- (1) MB-REDD safeguards roadmap, v2.0, for Vietnam's National REDD+ Action Programme: a contribution to a country-led safeguards approach
- (2) UN-REDD assessment of the institutional capacity to implement relevant policies, laws and regulations with respect to REDD+ safeguards;
- (3) UN-REDD assignment to develop a framework for a SIS and subsequent Technical Proposal for the Development of a SIS in Viet Nam;
- (4) UN-REDD review of grievance redress mechanisms (GRMs) and proposed design options for GRMs applied to implementation of REDD+ activities at national and (pilot) provincial levels; and
- (5) FCPF Strategic Environmental and Social Assessment (SESA) and resultant Environmental and Social Management Framework (ESMF) for the proposed subnational Emissions Reduction Program, as well as the subsequent national-level SESA planned for 2017.

4) TASKS ASSIGNED

The consultants will work in a team and jointly conduct the following specific tasks:

STEP A. Work and stakeholder consultation planning

- Contributing to development of a detailed work plan, with division of tasks among team members, stakeholder consultation plan and schedule of key milestone deliverables for the assignment, produced by VRO/PMU.
- 2) Contributing to a stakeholder consultation plan, to be implemented by VRO/PMU, into the work plan, outlining engagement with key stakeholder groups on draft iterations of final products (see Section 6), which includes:
 - a. Clear timeline, methods, steps, detailed activities;
 - b. List of stakeholders to be consulted
- 3) Assisting VRO/PMU in soliciting stakeholder feedback on draft iterations of key deliverables through a variety of methods, such as national consultation workshops, key informant interviews and draft report review.
- 4) Incorporating stakeholder feedback on draft iterations of final products (see Section 6) in revised versions.

STEP B. Developing the SIS database

- 1) Elaborating SIS database fields (columns) building on: a) the overview of proposed SIS database presented in the_Technical Proposal for the Development of a SIS in Viet Nam (see Annex I of these ToR); and b) other countries' experiences.
- 2) Ensuring SIS database design incorporates both Type 1 (how safeguards are being addressed) and Type 2 (how safeguards are being respected) information, with particular attention to subnational sources⁶ of Type 2 information on how PLRs are implemented in practice and the outcomes of that implementation.
- 3) Determining the specific qualitative, quantitative and spatial information, relating to national clarification elements concerning Cancun safeguards (a), (e), (f), and (g), that the REDD+ Geoportal will contribute to the SIS.
- 4) Identifying geospatial data, especially time series datasets, such as biodiversity maps, to be complied and aggregated in the SIS database (as indicated in the Annex 1).
- 5) Identifying feasible information and communications technology (ICT) solutions, based on existing

- FORMIS and REDD+ Geoportal configurations, for compiling, aggregating and disseminating information in the SIS so that any information of the SIS database can be provided via the REDD+ Geoportal later on.
- 6) Anticipating and accommodating (if and when possible) refined safeguards information needs, in the SIS database design, as a result of near-future benefit/risk assessments of PaMs comprising NRAP, national REDD+ investment plan and/or PRAPs.
- 7) Anticipating and accommodating (if and when possible) refined safeguards information structure (i.e. indicators), in the SIS database design, informed by near-future benefit/risk assessments of PaMs comprising NRAP, national REDD+ investment plan and/or PRAPs.

STEP C. Developing national and provincial safeguards information reporting templates

- 1) Developing information reporting templates, based on the SIS database design, for existing national information systems (Annex 2) and provincial sources⁷ (Provincial REDD+ Focal Agencies/Steering Committees/Teams/Units/Working Groups) to submit information to the SIS; to be done in consultation with the identified national and provincial information providers.
- 2) Determining, in collaboration with the FCPF project, how the SIS will gather and provide information on safeguards implementation for the proposed Emissions Reduction Programme, in the North Central Coast Region.
- 3) Determining how provincial pilot PGAs could contribute Type 2 information (on respecting safeguards) to the national SIS.
- 4) Proposing ICT solutions, formats and minimum frequency of different template submissions to the SIS, which are consistent and compatible with ICT arrangements of the national SIS (and underlying REDD+ Geoportal/FORMIS) compilation, aggregation and dissemination functions (see STEP B5).

STEP D. Institutionalising functional responsibilities for SIS operations

- 1) Exploring possibilities and proposing recommendations for a phased approach to integrating prioritised existing national information systems (Annex 2) and provincial sources (Provincial REDD+ Focal Agencies/Steering Committees/Teams/Units/Working Groups; FCPF-Carbon Fund's Emissions Reduction program; pilot PGAs) into the SIS.
- 2) Drafting terms of reference for a task team of core institutions, under the supervision of the National REDD+ Steering Committee, which would be responsible for ensuring institutionalisation of SIS operations in the immediate term (2017-2020).
- 3) Assessing the completeness and effectiveness of existing mechanisms, protocols or procedures for inter-agency information sharing across the 12 existing national systems identified as contributing to the SIS; proposing options of how to strengthen existing or, where necessary, creating new, interagency information sharing mechanisms, protocols and procedures.
- 4) Identifying financial, human, political and technological capacity needs for sustained SIS operations and developing an SIS capacity development plan (2017-2020).
- Identifying feasible and functional role(s) for non-state actors, particularly civil society, in SIS operations.

STEP E. Drafting first summary of information

- 1) Understanding relevant international guidance related to the preparation of summaries of information⁸, together with wider concepts and experiences of country approaches to safeguards
- Identifying which PaMs, under each of the relevant REDD+ activities, are to be included in the summary of information, drawing on the revised NRAP; draft iterations of the national REDD+ investment plan; endorsed and draft PRAPs; and latest draft of the proposed FCPF-Carbon Fund's **Emissions Reduction Program Document**
- 3) Determining, through a consultative process, what information on national circumstances is relevant to addressing and respecting UNFCCC (and other relevant) safeguards, including, inter alia:
 - i. The safeguards frameworks, in addition to the Cancun safeguards, that Viet Nam intends to

- respond to when implementing NRAP, investment plan, and PRAPs, for example, in accordance with Viet Nam's policy and funding commitments and priorities, World Bank, Green Climate Fund, bilateral donors, etc.
- ii. The main environmental and social **benefits and risks** identified for each PaM being implemented under the NRAP/PRAPs what priority environmental and social issues are to be safeguarded, and why?
- 4) Describing each UNFCCC safeguard in accordance with national circumstances, drawing on the most recent iteration of the national 'clarification of the UNFCCC safeguards' document
- 5) Summarising existing systems and processes relevant to addressing and respecting safeguards, in accordance with national circumstances, which could include, but not be limited to:
 - i. Viet Nam's country approach to safeguards
 - ii. SIS design process, development status and plans for operation
 - iii. FCPF SESA-ESMF
- 6) Synthesise and summarise existing information sources on how each of the national clarification of the Cancun safeguards could be addressed and respected when PaMs implementation commences, focusing on the following key governance elements:
 - i. For addressing Type 1 national-level information on existing statutory **PLRs**⁹, which could, on paper, address safeguards when it comes to the implementation of PaMs (<u>key resource</u> document 'Safeguards roadmap v2.0');
 - ii. For respecting Type 2 national-level information on existing state institutional capacities¹⁰ which could, in practice, contribute to respecting safeguards when it comes to the implementation of PaMs (key resource document 'Respecting REDD+ safeguards in Viet Nam: a preliminary assessment of institutional capacities to implement relevant policies, laws and regulations'); and
 - iii. For both addressing and respecting existing gaps, weaknesses and inconsistencies in the relevant PLRs, institutional capacities, together with plans to fill gaps¹¹, overcome weaknesses and resolve inconsistencies, which could improve how safeguards are addressed and respected in the future¹².
