- The supplier must adhere to the following “terms of offer submission”:

1. The supplier can tender for one group or all groups in the condition that he fulfills Item 2.
2. The supplier must be a practitioner of the profession s/he is tendering for and should submit a certificate that proves it “a previous contract – a certificate from the Agriculture or Commerce Chamber for the groups that s/he would like to make an offer for, etc...”.
3. All agricultural materials must fulfil the requirements of registration, analysis, and test adopted by the Ministry of Agriculture and Agrarian Reform.
4. (For Imported materials), the importing company must be on the ones authorized to work in Syria.
5. Items should be delivered in their original packaging as imported or manufactured; without taking any parts from them.
6. The supplier delivers all the items to the warehouses in the target areas on his defray.
7. The supplier should bear full responsibility for the costs, risks, and obtaining the necessary permissions required for the passage and delivery of the items.
8. The execution deadline is 25 days starting with the date of signing the contract or the date of issuing the payment order by the United Nations Development Programme in Syria (UNDP Syria).
9. The supplier can tender for one item or more.
10. One per mille of the total amount of the contract shall be subtracted for each day of delay, provided that the delay does not exceed 15 days.

11. The item shall not be paid for in case any of its contents is off-specifications.
12. The Programme has the right to return the items that do not meet the specifications, before delivery.
13. The supplier shall adhere to the terms related to the execution of the above mentioned business according to the criteria and specifications set by the authorized agencies in this field.
14. All contract procedures shall be carried under the regulations of the UNDP Syria.
15. All items requested in the above table should meet the specifications, be new and not refurbished, and guaranteed for a period that is not less than a year against malfunction. A technical committee shall check and receive accordingly.
