- 4. The percentage of Payment Terms in Section 3a: "Schedule of Requirements and Technical Specifications", page 25 has been amended as below:
- 20% of total contract shall be paid upon completion and approval of installation of network cabling, M&E (works, floors and partitions)

- 70% of total contract shall be paid upon completion and approval of fitting out including all construction and furniture
- Retention: 10% of the total contract shall be paid after 12 months from the date
 of certification of substantial completion (Defect Liability Period). During this
 period, the contractor shall be responsible to rectify any defects that become
 apparent in the Interior Fit out Works.
- 5. Clause 6 "Price Variation" in Section 3a: "Schedule of Requirements and Technical Specifications" page 26 has been removed from the Invitation to Bid Document.

This is a total lump sum contract price for the carrying out the whole of the works in conformity with the Drawings, specification and all conditions of contracts. There will be no adjustment to the contract sum for the fluctuation of labour cost, material costs or others.

- 6. The below Clause 10.1: Drawing in Section 3a: "Schedule of Requirements and Technical Specifications", page 27 has been removed from the Invitation to Bid Document.
