Detailed drawings for architecture and MEP will be created by the UNDP's architect. The selected contractor will be responsible for submitting the detail MEP drawing to Hong Kong Land to review and further coordination between the drawings and their implementation following Hong Kong Land regulation. The reviewing fee will be paid to contractor based on the actual cost to be charged by Hong Kong Land. Furthermore, the payment terms have been amended in the Notification of Amendment No 2 which is available on the UNDP website.

In this case what documents are prevailing: the drawings or the BOQ? what should be the base for our calculation	Yes, this is the "lump sum contract" and all quantities are provided in the 1st revised Bill of Quantities and Price Schedule Form (in PDF file) as attached in the "Notification of Amendment No.1" posting on the website. However, the Quantities mentioned in the 1st revised BoQ is estimate only. Hence, the final price for the lump sum is aggregated based on all provided documents: concept drawings, rendering and BoQ (which includes additional details compared to autocad files). Bidder has option to propose its quantities in the Price Schedule Form based on its review of all relevant documents.
