A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared. The price proposal will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical component.

The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR).

Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e.  $Sf = 1000 \times Fm / F$ , in which Sf is the financial score, Fm is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%.

Submission obtaining the highest weighted points (technical points + financial points) will be selected.

Interview with the candidates may be held if deemed necessary.

#### 5. Contract

#### I. INTRODUCTION

This Terms of reference (TOR) is developed to address the activities under the Output 2.2: "Increased capacity to undertake integrated land-use and environmental planning" under the "Enhancing Capacity for Implementing Rio Conventions" project.

The Project's Objective is: "To enhance the capacity for implementing the Rio Conventions by developing and applying tools that will lead to global environmental benefits". The Project attempts to achieve this through 2 Outcomes: 1. Viet Nam has the environmental management tools that fully address global environmental concerns; and: 2. Viet Nam is integrating global environmental concerns into its national strategic planning and development processes.

The project will support to attain output 2.2 "Increased capacity to undertake integrated land-use and environmental planning". In order to do that, the project is looking for 01 international consultant to support the development of a technical guideline for implementation of EPP in Vietnam.

#### II. BACKGROUND

In Viet Nam, the Government recently endorsed the Decree 18 on formulating EPP in conformity with the national and provincial Socio-Economic Development Planning (SEDP) processes.

The Articles that deal with EPP in Law on Environmental Protection in 2014 (LEP) and Decree 18 are included in their entirety in the Appendix. The most important aspects of these regulatory instruments include:

- "Planning for environmental protection refers to the environmental zoning scheme to conserve, develop
  and establish technical infrastructural systems for the environmental protection in line with a range of
  measures to be taken to protect the environment, which must be closely connected with the general
  planning for socio-economic development to aim for the sustainable development." (Article 3, clause 21
  LEP)
- EPP must "be harmonized with the general strategy and planning for socio-economic development, and the National Environment Protection Strategy with the aim of ensuring sustainable development".
- EPP is required at the national and provincial levels.
- EPP at the national level should result in a free-standing National Environmental Protection Plan.
- At the provincial level, EPP can either be free-standing, or integrated into a province's SEDP.

The Ministry of Natural Resources and Environment (MONRE) is currently developing the Circular and technical guideline on EPP to provide guidance on how to develop EPP at national and provincial level. The Ministry of Planning and Investment (MPI) is now developing the Planning Bill to harmonize different planning processes of line Ministries and sectors. The Law is supposed to be approved by National Assembly at the upcoming NA meeting.

This assignment therefore will support MONRE building both technical and institutional capacities in effectively formulating EPP to improve environmental and social sustainability of SEDPs.

#### III. OBJECTIVES

The assignment aims to support to develop a technical guideline for environmental protection planning (EPP) for implementing EPP in accordance with the Law on Environmental Protection and Guiding Decrees on EPP. The specific objective of this consultant assignment is to a complete a study which proposes and develops methodologies for calculating the carrying capacity of the environment (specific environmental elements, ecosystems or landscapes) for use both in the EPP planning process but also as an essential reference for orienting investment planning in provinces and for evaluating the "Environmental Impact Assessments" of specific investment plans.

# **IV. SCOPE AND TASKS**

# International Consultant-IC (15 days)

While liaising with the national consultants developing the overall EPP guidelines, the expert will have the following specific tasks:

Complete a review of international experiences on methodologies for calculating carrying capacity of environmental elements and their potential for application in the context of Viet Nam, facilitate discussions with the Vietnam Environmental Agency to select methods, and adapt those methods for integration in chapter of the EPP guidelines. (15 days)

- Conduct a thorough desktop review of globally recognized methods and experiences for calculating carrying capacity of different environmental elements (i.e water, soil, landscapes, air, living organisms), including but not limited to the following points:
  - o an assessment of approaches and methodologies used in different contexts (carrying capacity of environmental elements,; of ecosystems; or of landscapes). Prepare a presentation on the advantages and disadvantage, inclusive of a cost-benefit analysis, of each for the Vietnam context.
  - o key criteria for identifying carrying capacity or, the threshold value of human activity that the environment, and elements therein, of a certain region can bear under certain conditions over a period and where the normal function of the environmental system will not be adversely changed
  - o methods for identification of sources of pollution
  - o methods for determining theoretical baseline natural conditions and current status
  - o methods for calculation of absolute capacity (the maximum load for a certain pollutant that the environment can hold)
  - o methods for calculating the annual capacity (the maximum load for a certain pollutant that the environment can hold each year on condition that the accumulated pollutant concentration does not exceed the allowed maximum value of the environment standard)
  - O Assessing restoration (or cleansing) capacities of environmental elements in a given region and the requisite conditions and time periods needed for removal of excessive pollutant concentrations
- Develop and propose possible methodologies that could be adapted to the context of Vietnam to the VEA and related stakeholders to get comments and discuss on the application of approach/methodology for policy makers at national and provincial level
- Facilitate and guide discussions towards selection of the most suitable approach for Vietnam (ecosystem, landscape or environmental element) and methodologies that can be adapted and adopted by the VEA for piloting
- Adjust the chosen methodologies based on the comments/suggestions
- Work with Viet Nam Environment Administration (VEA), ISPONRE/PMU and NC team leader to agree on the outline of the chapter on environmental carrying capacity
- Produce the chapter on environmental carrying capacity in the technical guideline
- Work with NCs to integrate the methodology in to the EPP technical guidelines

- Develop the ToRs for a pilot carrying capacity assessment in a selected province that has already completed environmental zoning (such as Quang Ninh), as well as an estimated budget
- Contribute reference materials and ideas in support of creative communications, education, and training
  materials and programs that will serve to enhance the understanding capacity building on technical
  aspects of the carrying capacity of the environment and facilitate the development of EPPs.
