QUESTION 8. Should services under Lot 3 run in parallel with Lots 1 and 2?	ANSWER 8. Yes. Training and coaching support goes in parallel with the process of creating strategies and plans.
QUESTION 9. In the case of a successfully implemented project, will the developed methodology be used in subsequent years?	ANSWER 9. We expect that the strategies should allow for realistic medium-term planning in 7 ATHs. This period is 2 to 5 years. We expect that the communities will use the developed strategy during this period, before the next subsequent updates of these documents.
QUESTION 10. How can the ATH strategy be developed until 2022, if there is no country development strategy after the year 2020, also there is still no development strategy till 2025?	ANSWER 10. You can describe in more detail the elements of the strategy and/or plan for 2 years ahead, and plan the rest by scenario planning or trend analysis for the time scope accepted as medium-term planning.
QUESTION 11. Regarding the planning period of the strategy, how do you feel about different planning periods for different territorial hromada's, depending on their current state?	ANSWER 11. We ask you to prepare strategies that should allow realistic medium-term planning. This period is 2 5 years. Before determining the planning horizon, it will be necessary to justify the selected scope of time based on the specifics of the respective ATH.
QUESTION 12. Clarification on Lot 2 regarding budgets. In the RFP, the terms "budget of the management body" and "budget of the administrative center" were used. Does it mean that this is the cost of analyzing the budget of the self-government body, the total budget of the community, or something else?	ANSWER 12. It is necessary to create plans in relation to the effectiveness of 2 separate budgets: 1) the budget of the ATH's administrative city, 2) the total ATH budget. These are 2 separate documents; please ensure that the application foresees resources for working with 2 budgets in each of the 7 ATHs.
QUESTION 13. Do I understand correctly that for each lot you need at least 3,500 leaflets, also what is the Implementer's responsibility for their distribution?	ANSWER 13. For each Lot, 500 leaflets are needed, and each leaflet should present brief information on the products for all 7 ATHs in accordance with the respective Lot. We expect that the Implementer will send out leaflets in batches of 20-25 pieces and at 20-25 addresses.
QUESTION 14. Will the list of addresses for leaflets' distribution be provided by UN?	ANSWER 14. The UNDP will provide a mailing list of our key leaflet recipients, and we would also like to hear and discuss the winning company's proposals. UNDP together with the Implementer will complete the mailing list.
QUESTION 15. In case if quality and in-depth economic analysis of relevant statistics is missing, is it possible to use local or calculated data?	ANSWER 15. Yes, you can use such statistics. At the same time, we expect to be receiving qualitative analyzes from other RFP and pass these on to the winners of the current RFP, and for planning purposes it might be necessary to improve them slightly.
QUESTION 16. The analysis should be made in dynamics or it can be a situational cut?	ANSWER 16. In this task, we are talking about strategic products, as well as training and coaching support to planning. Analytical products for 7 ATHs will be provided to the winners by each Lot. We expect that certain indicators (the majority) will be presented as measured in dynamics over the previous 3 years, and some will be presented in statics.
