1	A bidder raised its concern regarding to their financial statement as this document is normally restricted by its Head Quarter based on its company's policy.	UNDP would consider this suggestion and notify the bidders if there would be the amendment to the Bidding Document.
2	Does UNDP require contractor to process tax exemption permit and the import custom clearance?	UNDP would process only the tax exemption permit from the General Department of Customs and Excise of Cambodia and Contractor would process the import custom clearance.
3	Please provide information on how to charge in the invoice?	Contractor shall charge MOPS prices of diesel and petrol plus a fixed premium fee in a monthly invoice and this shall be exclusive of import taxes, since the United Nations, including its subsidiary organs, is exempt from taxes.
