1	•	1) Is the period of the assignment 80days spread over 4 months or 120 days? When do we commence counting the 80 days?		 It is 80 working days spread over four (4) months. 120 days whereas indicates the validity period of a proposal to be submitted.
2	•	2) I see the "Recruitment National Consultant to Document Achievement of Women, Health Rights Policy Rights Policy Initiatives/Joint Program" on the Cover letter to the Technical Proposal, is this the programme under which the consultancy falls or its a template which can be modified?		 The title of the consultancy service is "Recruitment International Consultant for attachment of a Visiting Climate Expert to the SADC Climate Services Centre". It is corrected on the system which you can download it.
3	•	3) Section V of the TP, when is this consultancy expected to commence?. I am saying this in view of the almost fixed SARCOF periods which may happen slightly ahead of some of the deliverables in that section. Are these deliverables adjustable?		 The consultancy service started just after signing the contract. Presumably towards the end of August 2017 (a conservative estimate considering the time requires to complete the procurement due diligence)
4	•	4) There is a Subheading on Breakdown of Costs by Deliverables. I wanted to check if the deliverables in that table are part of the ToRs or they are set as examples. I also wanted to check if the apportionment of the percentage are pre-fixed or adjustable. Is there a lump-sum that could be paid at signing of the contract or its standard procedure that you follow the set		 The breakdowns are part of the contract. You just need to apportion the lump-sum amount into the four payment milestones.
5	•	5) What is the Duty station per diem for Botswana? The link provided gives the other per diems which seem different from the duty-station values.		 The per-diem for Botswana/Gaborone is US\$ 280.00 as per reference ICSC/CIRC/DSA/506 You could find it in countries alphabetical order.
