Together with the documents set, the participant must submit electronic scan copy of the Bid security in the amount of 10 000 USD for the Bid on one or several Lots if the Total amount of the Bid is between USD 200,000.00 and USD 399 999,99 or in the amount of 20 000 USD for the Bid on one or several Lots if the Total amount of the Bid is between USD 400,000.00 and USD 599 999,99 or in the amount of 30 000 USD if the Total amount of the Bid is more than USD 600,000.00

#	Question	Answer
1	Quite tough penalty sanctions are fixed in the ITB, and they are transferred further into contract.	These requirements are obligatory.
2	We know that this year MoH do not make advance payments. And the considered supply and payment for the goods delivered will be effected not sooner than in 4 months, i.e. next year. Is there any risk in case of UAH devaluation?	There are no risks connected to currency fluctuations for the suppliers, because UNDP has already received the tranche from MoH in USD for procurement of goods under current tender.
3	When we send bid offer to e-mail tenders.ua@undp.org we receive a confirmation only for the first e-mail or do not receive any confirmation at all. How could we understand our e-mails were delivered?	All is correct, it is our mail server configuration, confirmation e-mail is sent only for the first e-mail ever sent to the mentioned address.
4	The quantity of the delivered reagents purchased under 2016 budget 1.5 times exceeds the real demand in it. That is why supply under the current tender within 4 months will result in expiration of shelf lives (around 1 year) of reagents on the consignee stock and non-usage of the goods already purchased. That is why we offer to make deliveries not earlier second half 2018.	Taking into consideration the situation, let us inform the following indicative delivery terms: the first delivery of reagents for diagnostics of PKU and hypothyroidism (50% of the total amount under 2017 Budget) is to be made until the end of May 2018; the second — until July 2018. Supply of reagents under 2016 Budget savings should be made within the terms stated in tender document (within 4 months from the date of purchase order issue). Please, see the updated Annex 4.

5	Some producers do not want to put data loggers into packing boxes.	This requirement is an obligatory requirement of MoH to the goods supplied.
6	Sometimes it is difficult to receive reference letters from some companies. Is it allowed to use references from previous tenders?	In case of confirmation of the companie's experience – it is allowed, if the given reference was for the company and was not linked to the previous tender.
7	Information on litigations, should we present all the information about all litigations?	All information regarding any past and current litigation during the last five (5) years, in which the Offeror is involved, indicating the parties concerned, the subject of the litigation, the amounts involved, and the final resolution if already concluded.
