As per Point 19 of the Request for proposal, bidder can form a joint venture with another entity. Please refer to this point for further detailed requirements.
2	Is the duration for service implementation 8	It is not required for bidder to notify UNDP of the joint vendor in advance. No, the duration for the service implementation is 12

5	Is it correct that the RFP requires 3 trainings (each training course is 3 days)?	This is the minimum that must be provided by the contractor. The quantity and duration of each training shall be determined after need assessment. Bidders can propose their ideas after need assessment.
6	Are costs for accommodation, meals, travel for training participants included in the proposal?	The costs for accommodation, meals, travel for training participants as well as costs for organizing trainings (venue, coffee break) shall be borne by the project. Other costs such as activities in laboratories or sample taking shall be borne by bidder.
7	Is it possible to have information of the laboratories which are benefited from this service?	Currently the information on laboratories which are benefited from this service is not available. The laboratories are located in the north, central and south of Vietnam. It is estimated that at least 40 technical staff shall be trained.
8	Can bidder form joint venture with a beneficiary laboratory?	No. If bidder need to form a joint venture with a laboratory, it should be a laboratory that is not benefited from this contract.
9	Are the chemicals included both POP and PTS?	Yes. The main chemicals are in POP list of Stockholm Convention and mercury. During trainings, different laboratories may be trained with different chemicals as per their requirements.
