The equipment should be imported in the name of UNDP and UNDP will issue a facilitation letter to company for customsclearance. Please note that it will be successful bidder's responsibility to clear the shipment and deliver at site. Further, the company should submit the request to UNDP 2-3 weeks prior for obtaining exemption letter.
4	Is there any condition for brands/country of origin for the equipment listed in the BOQs	There is no preference on the country of origin. The equipment meeting the required specifications as well as offering the warranty coverage will be accepted by UNDP. The bidders must offer the local maintenance and after sale services.

6	Specification 09560 not mentioned in ITB	There is a typo. The correct number should read as 09650 instead of 09560. Section 09650 is available in Technical Specifications.

7	In ITB section 7 page 53 is not clear	The bidders must provide the summary of each category (Architectural, Mechanical, Electrical, Structural, Signage) exactly as listed in the BOQs in excel.
8	Is there any independent party to monitor the work	There is a strong likelihood that UNDP will hire a third- party consultancy firm to monitor the work. In parallel UNDP Engineers will also monitor the progress of the work on daily basis.
9	Will it be possible to extend the deadline for submission	Based on various request received from the firms/companies, the deadline has been further extended till 31 January 2018.
10	Can we submit our bid as Joint Venture	Yes, you can submit your bid as Joint Venture. The company should submit the clear agreement between both parties; experience details, bank statements and clear roles and responsibility for each entity.
11	Site Work Item 1.4 the formula is not correct	The formula has been corrected and revised BOQs has been uploaded with the event.
