# FOR THE RECRUITMENT OF A CONSULTANT TO DRAFT A REGULATARY TEXT FOR THE IMPLEMENTATION OF THE ACCESS AND BENEFIT SHARING BILL WHEN ENACTED

#### I. BACKGROUND

The Convention on Biological Diversity (CBD) was adopted on 5 June 1992 at the Earth Summit in Rio de Janeiro and it entered into force in 1993. Its objectives are biodiversity conservation, sustainable use of its components and access to genetic resources and the fair and equitable sharing of benefits arising from the use of genetic resources (ABS). To effectively implement the third objective, there was need to negotiate an international regime that will promote and safeguard the fair and equitable sharing of benefits arising from the utilization of genetic resources. This need was further accentuated by developing countries who have for a long time been complaining of misappropriation of their genetic resources by developed countries.

In response to this situation, at the 7th meeting of the Conference of the Parties in 2004, an Ad Hoc Committee was established with the mandate to develop and negotiate an international regime on access to genetic resources and fair and equitable sharing of benefits specially to implement Article 15 (access to genetic resources) and 8 (j) (traditional knowledge) of the Convention. After 6 years of negotiations, the Nagoya Protocol on ABS was adopted in the city of Nagoya, Japan on 29 October 2010. It establishes legal certainty and transparency for both providers and users of genetic resources.

Cameroon Country, Party to this Convention has been an active member in all the negotiating processes of the protocol and thanks to its enormous biological and cultural potentials, it benefited from GEF / UNEP funds to implement this Protocol precisely by using two value chains (*Echinops giganteus and Mondia whitei*) to build local and national capacities as well as develop a law on ABS. Moreover, an ABS Strategy was elaborated and validated in 2012 while its action plan was validated in 2016. The strategy spells out the need to develop a specific law on ABS with its regulatory texts. It is also worth noting that these two value chains are from Lebialem Division in the South West Region precisely from the localities of Magha-Bamumbu (Echinops giganteus) and Lewoh (Mondia whitei). Essential oils are extracted from these species by a French company V MANE FILS for a possible use in the cosmetic industry.

In 2016, Cameroon benefitted through the Ministry of the Environment, Nature Conservation and Sustainable Development benefited from the GEF/UNDP funding, a medium sized project whose aim is to build capacities at the national and local levels to develop value chains for *Echinops giganteus* and *Mondia whitei* that are compliant with ABS principles enshrined in the Nagoya Protocol. The project will also use these value chains to elaborate a specific law on ABS in Cameroon. The law currently being drafted will be examined and if possible adopted by all stakeholders at the national level in the days ahead and then submitted to hierarchy for onward transmission. In this regard, it will be very important for it to be accompanied by regulatory instruments to facilitate its effective implementation. This is the purpose of these terms of reference.

#### II. GENERAL OBJECTIVE

The main objective of this assignment is to recruit a consultant to draft a regulatory text for the implementation of the access and benefit sharing bill when enacted.

#### III. SPECIFIC OBJECTIVES

- 1. Draft a regulation under the access and benefit sharing bill that will specify but not limited to:
- Modalities for the Valorisation of GR and TK Cross Sectoral Integration
- Access Conditions
- Types of Access
- Access Standards (research, commercialisation, emergencies, etc..)

- Access Procedures (PIC and MAT)
- Benefit Sharing Conditions
- Types of Benefits
- Benefit Sharing Standards (GR, TK,)
- Benefit Sharing Agreements
- Measures for Control and Monitoring (check points),
- 2. To prepare the explanatory Memorandum of the Decree
