1	It is stated in ITB 59-2017-UNDP-UKR that delivery of the products should be done within half year: "Early delivery of medicines to Ukraine is critical therefore we encourage shortest delivery periods. 100% quantities must be delivered within 6 months at the latest after signing the contract. The bids with later delivery dates will be disqualified".	This is a standard condition for the medicines. As to radiopharmaceuticals the delivery timeframe is agreed separately based on hospitals demands (on a monthly and weekly basis) and further could exceed 6 months.
2	It is stated in ITB 59-2017-UNDP-UKR that tender is conducted for 4 lots, including "Samarium (153Sm) lexidronam (153Sm) oxabifor". Is it allowed to submit bid offer without this lot?
