General Conditions for Tender

- 1. Scope: SCA Procurement invites tenders for the good described and summarized in accordance with procedures, conditions and contract terms, as prescribed in the tender documents. The Procurement unit and SCA reserve the right to vary the amount of good (Special education material) specified in the Tender Documents without any changes in unit price or other terms and conditions and to accept or reject any, all, or part of submitted offers.
- **2. Language:** As determined by SCA, the working language of this tender is English, Pashto and Dari.

Other languages will not be accepted.

- **3. Source of Financing:** The program and project are financed by SIDA the Investor is considered SCA for contracting purposes.
- **4. Qualifying and Conditions:** The main criteria for admission to the tender are as follows:
 - a) Must be registered firm (Copy of business license must be attached with offer)
 - b) Must have recognized company bank account (SCA will make all payments in bank checks or through bank transfers to the name of the company).
 - c) Interested Local firms must have Tax Identification Number (TIN).
 - d) Bidders must not be currently black-listed by SCA and/or Afghan Government (NPA)

Proof of the above (a-c) must be provided in a sealed envelope or attached with offer while submitting bid either via hard copy or electronically.

5. Tender Basis:

- Bidders are requested to fill the section 1 (Qualification Information Form) which has been provided below. Failure to do so may result in disqualification
- None of the parts of the contracts is allowed for subcontracting to third party (ies)
- All pages of the tender document shall be stumped by the bidder. Declaration of eligibility
 form shall be filled, signed, and stumped. Failure to do so will result in disqualification.
 Unless supplier proposes an alternative solution, supplier stump declares supplier's
 acceptance for all the terms mentioned in any certain page.
- All bids shall be made in accordance with the Tender Documents including technical specification, bill of quantities, and/or activity schedule and the draft of the contract intended to sign with the successful applicant.
- All Applicants will receive identical documents: No applicant should add, omit, or change any specification, term or condition on original papers.

- If Applicants have any additional request and conditions, this shall be stipulated in a separate letter accompanying the bid. Each bid shall be valid for the period of 45 days from its date of submission.
- Bids shall be made in writing calculated in USD only and clearly stated on the appropriate forms.
- All prices must include all taxes, compulsory payments, levies and duties.
- Clarifications regarding the specification, quality, delivery, timing that are not addressed in tender documents must be raised in writing to the SCA. The answer to any question raised in writing by any applicant will be issued to that applicant by letter. However, it is a condition of this tender that no clarification shall be deemed to supersede, contradict, add to or detract from the conditions hereof, unless made in writing and signed by the Procurement Manager or designated representative.
- Packaging, appropriately tagging (issuing shipping notes), delivering to SCA is the responsibility of the contractor (further guidance could be sought from SCA Procurement unit on this upon successful contract award).
- The period of performance and delivery of (**Special education material**) will be 30 calendar days starting from the day the supplier confirms Purchase Order; each working day delay may be deducted @0.05% from the total of the contract amount (One week = 5 working days).
- **6. Payments:** SCA will process the payment in USD currency and in one instalment after successful delivery of Special education materials to Kabul Airport.
- **7. Performance Standards:** The services must be undertaken in accordance with all relevant rules, regulations, statutes and highest standards currently in force in Afghanistan.
- **8. Eligibility of Applicants:** Applicants cannot apply if they:
 - Are not registered companies.
 - Are bankrupt or in the process of going bankrupt.
 - Have been convicted for an offense concerning professional conduct.
 - Have been guilty of grave professional misconduct (proven by any means which the contracting authorities can justify).
 - Have not fulfilled obligations related to payment of taxes.
 - Are guilty of serious misinterpretation in supplying information.
 - Are in situations of conflict of interest (with prior relationship to project or family or business relationship to parties in SCA).
 - Were declared at serious fault of implementation owing to a breach of their contractual obligations

- Are on any list of debarred firms issued by the SCA and/or Government of Afghanistan (NPA).
- **9. Bid Opening:** The bids will be opened only in the presence of the Procurement Committee, at the date specified by the committee. Public bid opening is not applicable.
- **10. Bid Evaluation:** The committee will check the tenders to ensure that they contain no amendment to the terms or any other (calculation) errors and that the documents as well as criteria outlined in the tender documents are provided by the tendering or offering party. This process will be called preliminary evaluation. All bids will be initially reviewed as per the criteria outlined in Clause 4 of General Conditions for Tender. Bidders who fail the preliminary evaluation will be automatically disqualified.

Technical Evaluation: Only bidders who pass the preliminary evaluation will be qualified for technical evaluation. The offers will be evaluated on technical merits including minimum specification requirement. Each item will be evaluated separately. Only those items which pass the technical specification will be presented for financial comparison.

Financial Evaluation: The financial evaluation is based on the cost given for each item. SCA may carry item wise selection if it is in best interest of SCA. Suppliers will be informed of their total winning items and amount. SCA reserves the right to award multiple purchase orders.

- **11. Selection of Tender:** Selection can be item-wise. Selection of the bidders can be based on their total winning items. Items which fail the specification check will not be considered for financial comparison.
- **12. Acceptance of Successful Tender:** Taking into consideration the recommendation of the Committee, SCA will make the final choice of the awarded firm. SCA may then send a letter of acceptance to the successful applicant. After submitted documentation from the selected firm has been verified, the firm will then be obliged to sign the contract for the stated amount. Any amendment to the awarded tender will be documented as an "Annex" to the contract and will be determined by SCA.

- **16. Delivery Location:** all special education item will be delivered to CIF Kabul Airport Afghanistan. All transportation will be the responsibility of Supplier. Suppliers are required to calculate total freight charge and include it in their offer.
- **17. Delivery time and Penalty:** The period of performance and delivery for this procurement will **be 30** calendar days starting from the day supplier confirms the Purchase Order. In case of late supply, each working day delay may be deducted @0.05% from the contract total amount (Week = 5 working days).
- **18. Tax Deduction:** Considering article 72 of Afghanistan Tax Law, SCA will deduct all applicable taxes (2% from local firms who have AISA or Trade License and 7% from all international suppliers). Bidders must consider all applicable taxes in their unit price before submitting final offer. SCA will not be accountable for taxes required in participating bidder country. While submitting offer, it is the responsibility of bidders to consider their home country tax as well as Afghan government tax which is 7 % for international firms.
- **19. Seeking Clarification:** If there is a need for clarification regarding this tender, please raise your concern to SCA Procurement Unit via Bids@sca.org.af at least 3 days before the bid submission deadline. Please make sure the tender number is quoted in the subject line of your email. Kindly refrain from any telephonic or face to face communications.
