Answer 2: it is Part of the financial proposal; any financial data should be part of the financial proposal.

Question 3: What kind of remote sensing documents will be provided for the land unit identification and delineation?

Answer 3: ArcGIS shapefiles and the GIS system is PAL Grid.

Question 5: What is the expected GIS database format? **Answer 5:** Shapefiles, (X, Y) and description data of augers.

Question 6: What is the report language, format and number of copies? In regard to the presentation, how should it be presented, by workshop or in a meeting?

Answer 6: Number of original copies: Two reports should be submitted: one in English and one in Arabic; number of copies: 5 soft copies of each language, and five hard copies of each language, the presentation will be in a meeting held at Ministry of Agriculture.

Question 7: Soil classification will be according to FAO WRB 2006 or FAO WRB 2014? **Answer 7:** FAO WRB 2014

Question 8: For the international applicants, can we submit the proposals (financial and technical) via Email?

Answer 8: No, only separate sealed envelopes.

Question 9: For the soil analysis parameter and the total of samples, is it fixed or is subject for change?

Answer 9: The parameters and the total of samples are an estimation; the technical and financial proposals need to clarify the parameters and the expected total samples for each.

Question 10: What do you mean by "one offeror, who submits the first lowest Price quote amongst the technically responsive offers"

Answer 10: Lowest-priced among technically compliant offer (point system with a minimum threshold). The financial proposal of only those offerors obtaining the minimum 70% score during technical evaluation should be opened. The remaining financial proposals of offerors whose technical proposals are deemed unqualified and non-responsive shall be remain unopened. The contract will be award to the company meeting the minimum 70% score in the technical evaluation and offering the lowest price.

Interested bidders shall acknowledge receipt of this addendum/pre-bid minutes by returning/including it, signed and stamped, with their bids.
