After UNDP has identified the lowest price offer, UNDP reserves the right to award the contract based only on the prices of the goods in the event that the transportation cost (freight and insurance) is found to be higher than UNDP's own estimated cost if sourced from its own freight forwarder and insurance provider.

At any time during the validity of the quotation, no price variation due to escalation, inflation, fluctuation in exchange rates, or any other market factors shall be accepted by UNDP after it has received the quotation. At the time of award of Contract or Purchase Order, UNDP reserves the right to vary (increase or decrease) the quantity of services and/or goods, by up to a maximum twenty-five per cent (25%) of the total offer, without any change in the unit price or other terms and conditions.



Scope of Works Rehabilitation of Rainwater Drainage Network, Manholes and Drainage Channels in Anah Anah City – Anbar Governorate – Iraq


Background

The project's aim is to rehabilitate and clean the rain water drainage network, manholes and drainage channels in Anah, the drainge network and channels pass through many districts in Anah city and all these districts will be served by this project (25,000 beneficiaries);.


See below aerial maps show the locations and GPS of the project.











The project includes the following parts:

A- Cleaning the Sewage pipes network and manholes:

The work includes; cleaning the main and sub sewage manholes, and all underground sewer UPVC pipes networks in various diameters and manholes of Jumaila district, removing rubbish and debris outside the city borders to a dump site approved by the relevant authority

B- Cleaning the Rainwater Drainage channels for 1st and 2nd Al-Yarmouk , Jumaila ,Al-Nasr districts

The work includes; cleaning, excavating, making a suitable slope along the rainwater drainage channel, with well cleaning all sides of the drainage channels for 1st and 2nd Al-Yarmouk, Jumaila ,Al-Naser districts with well cleaning all sides of the drainage channels using excavators with long Boom and arm, shovels truck and any heavy equipment that may be needed, cleaning the main pipe which transporting the sewage water from the treatment plant to the channel using jetting truck, removing and transporting all old debris and trash existing along sides of the channel in addition to all needs and new wastes of excavating and clearing processes of the drainage channel from the site to a dump site approved by the relevant authority.

C- Cleaning the By Pass Channel of Anah Sewage Treatment Plant

The work includes; clean, excavate, make a suitable slope along the by pass channel of Anah sewage treatment plant with well cleaning all sides of the drainage channels using excavators with long Boom and arm, shovels truck and any heavy equipment that may be needed, cleaning the main pipe which transporting the sewage water from the treatment plant to the channel using jetting truck, removing and transporting all old debris and trash existing along sides of the channel in addition to all needs and new wastes of excavating and clearing processes of the drainage channel from the site to a dump site approved by the relevant authority. • Schedule of Requirements and Technical Specifications

The Contractor shall visit the designated sites to be familiar with the condition of the work areas, the structures, it is the bidders' responsibility to acknowledge the site conditions before submitting the bids.

In general, the Contractor should be familiar with all current conditions and circumstances which may affect the work progress.

The Contractor shall implement the Project based on a detailed work plan which shall be approved by the Project Engineer. The contractor is expected to produce/perform works which conforms in quality/quantity and accuracy of detailed specification. The Contractor is to institute a quality control system to ensure adequate monitoring of the works progress at all times.
