A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared. The price proposal will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical component.

The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR).

Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e. $Sf = 1000 \times Fm / F$, in which Sf is the financial score, Fm is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%.

Submission obtaining the highest weighted points (technical points + financial points) will be selected.

Interview with the candidates may be held if deemed necessary.

1. Background:

Forestry development in Viet Nam has made a great progress. By the end of 2017, the forest coverage reached 41%, while the average growth rate of production value was 6.57%, the export value of wood and forest products generated at USD7.9 billion, (Vietnam Administration of Forestry, 2018).

The forestry sector is moving towards sustainable development with natural forest land conversion to be strictly controlled and value chains for both timber and non-timber products are expected to be substantively increased. The sector however faces a great challenge in term of resource mobilisation to finance its sustainable agenda. The State budget's proportion tends to decrease to meet only about 30% of total investment demand, while the rest relies on non-state budget including those covered by private sector. In order to mobilze different resources for forest protection and development, especially for natural forests, Lao Cai province has piloted a new approach in allocating protection forests to several businesses, aiming at finding appropriate private-public partnership modalities to engage business sector in sustainable forest protection and development activities. The pilot has been initiated since 2014-2015.

UN-REDD Viet Nam Phase II Programme funded by Norway through 3 UN participating organizations (FAO, UNDP and UN Environment) in partnership with Ministry of Agriculture and Rural Development, has been supporting the Viet Nam to revise and roll out the implementation of the National REDD+ ¹Action Programme (NRAP) for 2018-2030. Some key among the measures under the NRAP are to explore sustainable opportunities/modalities to effectively engage private sector in doing profitable business with forest related goods and services.

To support the NRAP implementation in this regard, UN-REDD Programme is about to support Lao Cai to document its lessons learnt from the pilot models serving as inputs for policy dialouges on forms/modalities of public-private partnership for natural forest protection and development nation-wide. This is to call for 03 national consultants to support to conduct this evaluation process.

2. Scope of Assignment:

2.1 Objectives

This assignment is designed to assess the efficiency and effectiveness of the pilot models in Lao Cai to generate policy recommendations on how to engage business sector in profitable and sustainable business models in natural forest protection and development. The assessment is expected to clarify the added values of the piloted model in comparison with the tradditional ones, in particular:

- The **efficiency ratios** of this private-public model through analysis of cost and benefits (inputs vs. outputs)

¹ REDD+: reduce **e**missions from **d**eforestation and forest **d**egradation, and foster conservation, sustainable management of forests, and enhancement of forest carbon stocks.

- The **added values** of this new partnership in forest protection, in generating forest related values and benefits
- The **level of participation of local people** in making such decision; the clarity of their roles, responsibilities and capacity to (i)participate throughout the implementation of forest protection plan, M&E, and (ii)control over the benefit sharing and grievance mechanisms
- Value for money of this model (inputs vs. outcomes)
- Recommendations on appropriate models/modalities of the private-public partnership for natural forest protection and development

2.2 Main assignments

- Reviewing all applicable policies, procedures and practices on allocating and contracting protection forests to non-state economic organizations;
- Designing tools for survey and evaluation of the model in Lao Cai;
- Conducting field evaluation to assess the 3 pilot models of forest contracting for protection to business entities in Lao Cai on above mentioned elements.
- Writing a report to summarize the findings and recommendations to respond to the above objectives of the assignement.
- Organizing the expert consultation meetings;
- Summarizing policy recommendations and implications for up-scaling the models;

2.3 Methods:

- Desk reviews on allocating and contracting forests for protection policies/literatures and practical experiences.
- Data collection (secondary data) from periodical and annual reports on the changes of forest resources, quality and effectiveness of forest management by economic organizations in Lao Cai
- On sites surveys and evaluation (key informants' interview, and observations). The comparative case study might be employed to highlight the added values of the new elements, the associated costs and benefits of the pilot (with and without or before and after comparation)
- Conduct group discussion/expert consultations
- Carrying out costs and benefits (CBA) analysis of theforest protection and allocation models by economic entities;
- Delivering policy recommendations at Policy dialogue workshop
- Writing the main report and the policy brief.

3. Time, location and supervision

- Time: From May to October 2018
- Location: Hanoi and travelling to Lao Cai
- The consultants will be technically backstopping by related UNDP's and UN-REDD's experts and will be administratively supported by PMU of the Programme and UNDP where relevant throughout the implementation of the assignment.
- The consultant will work under the supervision of UNDP, the Chief Technical Advisor and National Programme Director of UN-REDD Viet Nam Phase II.

During the assignment, the team of consultants are expected to spend about 7 working days at least in Lao Cai for the field study. Therefore, the financial offer given by the consultants needs to fully cover this mission cost. In case the consultant is requested to travel outside Ha Noi and Lao Cai, a separate arrangement will be made by either PMU or UNDP (whichever more convenient) based on UN-EU Cost Norms.

4. Expected results:

The consultants are expected to work together under the leadership of the lead consultant (consultant #1 below) to jointly deliver the following products.

<u>Product 1</u>: Joint workplan is developed and submitted to UN-REDD Programme and UNDP. This also clarifies the work division among the consultants.

<u>Product 2</u>: Brief report on lessons learned from domestic experiences in allocating or/and contracting natural/protection forests to private businesses to protect and manage;

<u>Product 3</u>: A brief report on policies and legal framework for allocating/contracting forests to local economic organizations to protect and development: enabling and discentivizing factors and issues;

<u>Product 4</u>: Evaluation report on key findings and recommendations from the piloted sites in Lao Cai province as described by the objectives of the assignment.;

<u>Product 5</u>: A set of policy recommendations for possible up-scaling the piloted models in the framework of implementing NRAP, NRIP and the sustainable forest development agenda.

5. Requirements for the consultants:

In order to carry out the task described above, a team of three experts is required to work under the leadership of one among them.

- 1. An economist, team leader, expert in CBA, financial analysis and business development, in charge of formulating the technical/strategic aspect of recommendations: 35 workdays
- 2. A legal expert, in charge of the review of policies and regulatory framework, and the legal-translation of formulation of policy recommendations: 30 workdays
- 3. A stakeholders' engagement expert, community participation to forest management etc. to bring a "comparative" perspective to what the company does offer: 20 workdays
