# REQUEST FOR PROPOSAL FOR- "BIODISCOVERY CONSULTANCY"

# A. Project Title:

GEF ABS Project "Strengthening human resources, legal frameworks, and institutional capacities to implement the Nagoya Protocol".

### B. Project Description or Context and Background:

The Nagoya Protocol on Access to Genetic Resources and the Fair and equitable sharing of Benefits arising from their utilization (ABS), an agreement under the Convention on Biological Diversity (CBD), was adopted on 29 October 2010 in Nagoya (Japan) and entered into force on 12 October 2014, it provides a transparent legal framework for the effective implementation of the 3<sup>rd</sup> objective of the CBD. The protocol applies to genetic resources that are covered by the CBD and to the benefits arising from their utilization, it also covers traditional knowledge associated with genetic resources (TKAGR) held by local communities (LC). Parties to the Nagoya Protocol need to fulfill core obligations to take measures in relation to access to genetic resources, benefit-sharing and compliance.

A global GEF project "Strengthening Human Resources, Legal Frameworks, and Institutional Capacities to Implement the Nagoya Protocol" was formulated by UNDP with the participation of 24 countries from Eastern/Central Europe, Arab countries, Africa and the Asia-Pacific Regions. Samoa is one of the participating countries in this project. The project has the objective of assisting countries in the development and strengthening of the national access to genetic resources and benefits-sharing (ABS) frameworks, human resources and administrative capacities to implement the Nagoya Protocol. The project duration will be for three years starting from mid of 2017 and three components will be implemented:

- I. Strengthening the legal, policy, and institutional capacity to develop national ABS frameworks;
- II. Building trust between users and providers of genetic resources to facilitate the identification of bio-discovery efforts;
- III. Strengthening the capacity of indigenous and local communities to contribute the implementation of the Nagoya Protocol.

UNDP is providing technical advice and assistance to the Government of Samoa to meet its commitments under this project. The Division of Environment and Conservation (DEC) under the Ministry of Natural Resources and Environment (MNRE) is the 'national focal point' responsible for leading this project on behalf of the Government of Samoa.

Samoa became a party to the Convention on Biological Diversity (CBD) in 1993 and the Nagoya Protocol was ratified in 2014. There is no specific ABS regulation in place however the draft Environment Management and Conservation (EMC) Bill which has provisions for bio-prospecting.

### C. Scope of Work:

Under the close supervision of the ABS Project Manager-Samoa (ACEO-DEC) and the Regional Project Advisor, the consultant will be responsible for technical contributions to the required analysis and consultations with the key stakeholders to ensure that their contribution is provided with a view to achieving the projects objectives.

## 1. Objective

The Consultant will in particular play a central role for the following activities, with the support from the regional project advisor and ABS Project Manager/Coordinator in implementing activities outlined under this project.

- Participate and facilitate the coordination meetings with the Project stakeholders (Relevant Government Ministries, Private Sector, NGOs and local communities) to scope existing biodiscovery projects specifically on Samoan and non-Samoan genetic resources (GRs) and associated traditional knowledge (ATK), identify main users and providers of GRs and ATK in Samoa;
- Conduct the review, gap assessment and analysis on the current biodiscovery partnership of GRs and ATK in Samoa, main users and providers of GRs and ATK, elements for a successful biodiscovery, as well as make specific and appropriate recommendations required to build successful biodiscovery partnership leading towards fair and equitable sharing of benefits.
- Produce outputs as detailed below.
- Conduct the validation workshop on the analysis and recommendations with the participation of relevant stakeholders, including IPLC and women association, as advised by the Project Coordinator.
