#### 5 FINANCIAL PROPOSAL

The candidates, who are technically qualified will be requested to submit financial proposals as per the template which will be shared with the shortlisted candidates only, after the technical evaluation of the documents indicated in Section 4 of Procurement Notice.

#### 6 EVALUATION

The evaluation will be based on cumulative analysis (i.e. technical qualifications and price proposal). The weight of the technical criteria is 70%; the weight of the financial proposal is 30%.

Candidates who obtain a minimum of 70 pts out of a maximum 100 pts will be considered for the financial evaluation.

Candidates who do not meet the minimum requirements indicated in Article 7 of the Terms of Reference will be disqualified.
