A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared. The price proposal will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical component.

The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR).

Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e. Sf = 1000 x Fm / F, in which Sf is the financial score, Fm is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%.

Submission obtaining the highest weighted points (technical points + financial points) will be selected.

Interview with the candidates may be held if deemed necessary.

1. Background

The Capacity Building Initiative for Transparency (CBIT) fund was created in response to the Paris Agreement to assist countries in their efforts to foster technical and institutional capacities in the context of achieving greater transparency in their actions.

The CBIT launched in GEF-6 will be mainstreamed in the GEF-7 Climate Change Mitigation Focal Area Strategy to support projects that build institutional and technical capacity to meet the enhanced transparency requirements in the Paris Agreement. The CBIT aims to (a) strengthen national institutions for transparency-related activities in line with national priorities; (b) provide relevant tools, training and assistance for meeting the provisions stipulated in Article 13 of the Agreement; and (c) assist in the improvement of transparency over time.

The Government of Viet Nam ratified the Paris Agreement of the United Nations Framework on Climate Change and in its Nationally Determined Contribution (NDC) has set a target to reduce greenhouse gas emissions 8 percent by 2030, or 25 percent with international support, compared to business-as-usual. Viet Nam is now also in the process of reviewing and updating its NDC, which will be finalized in 2019. Additionally, Viet Nam has also issued the Plan for Implementation of the Paris Agreement in 2016, and the National Climate Change Strategy in 2011. included. Viet Nam submitted its First National Communication to the United Nations Framework Convention of Climate Change in 2003, the Second National Communication to the United Nations Framework Convention of Second Biennial Updated Report in 2017.

The proposed CBIT project for Viet Nam will build upon these efforts and fill in the gaps in order to develop adaptive capacities at the national level in terms of reinforced transparency framework and meeting the provisions stipulated in Article 13 of the Paris Agreement.

The Ministry of Natural Resources and Environment (MONRE) and the United Nations Development Programme (UNDP) are looking for a team of one international consultant and one national consultant to prepare a Project Identification Form (PIF) of the proposed CBIT project for submission to the GEF.

2. Objective of the assignment

The objective of the assignment is to formulate a Project Identification Form (PIF) for submission to GEF's CBIT funding window by November 2018.

3. Scope of work

3.1 General tasks and activities

The international consultant and national consultant will form a consulting team. The team takes joint responsibility to prepare and finalize a high-quality PIF. To fulfil this responsibility, the team should undertake the following tasks, but may not be limited to:

- 1. Review international best practices and experiences on UNFCC's requirements including MRV systems related to climate change mitigation, adaptation and finance for meeting reporting and transparency requirements under the Paris Agreement and NDCs.
- 2. Undertake a review of Viet Nam's NDC, NC, SNC, BUR (2014;2017) and other relevant documents (reports, plans, acts, including government and donor strategies) of Viet Nam's progress for meeting enhanced transparency requirements as defined in Article 13 of the Paris Agreement. This will include but is not limited to (i)Tracking progress towards achieving Viet Nam's Nationally Determined Contribution, including the efforts and targets relating to Climate Change Mitigation, Climate Change Adaptation, and MRV; (ii) Providing information on financial, technology transfer and capacity building support in line with the Paris Agreement transparency framework. The review will ensure alignment with existing related work and avoid duplication of efforts.
- 3. Review and analyze of Viet Nam's existing mechanism/frameworks for the collection and management of all data relevant to development of a national climate change MRV system for adaptation and mitigation, identify the gaps and areas that need support, including capacity building and technical inputs, and consult with government, UNDP, and other relevant stakeholders.
- 4. Clearly define the scope and key elements of MRV/transparency mechanism best suited for Viet Nam, which includes transparency related to targets and budget on mitigation, adaptation, and finance, and consult with UNDP, Government, and relevant stakeholders.
- 5. Develop draft PIF that addresses all required components outlined in PIF template (see annex 1) and hold consultations with UNDP, MONRE, and other stakeholders.
- 6. Incorporate feedbacks from consultations and finalize the PIF for submission.
- 7. Provide written responses and revisions of the PIF based on feedback received from GEF Secretariat.

3.2. Specific tasks and activities

The *international consultant* (team leader) will take full responsibility to develop and finalize the PIF. Specifically, the international consultant will perform the following tasks:

1. Provide technical advice and guidance to the national consultant to perform the task from beginning and during the process, including identification of the data and information to be collected, consultation with relevant stakeholders, the division of work to complete all sections

of the PIF, and review, oversee and comment on national consultant's outputs to ensure the quality and the sufficiency of the inputs.

- 2. Lead the review of Viet Nam's NDC, SNC, NC, BUR (2014;2017) and other relevant documents (reports, plans, acts, including government and donor strategies) to ensure that the CBIT PIF is fully aligned with them.
- 3. Lead the review of international best practices and experiences on MRV systems related to climate change mitigation, adaptation and finance for meeting reporting and transparency requirements under the Paris Agreement and NDCs.
- 4. Lead the defining of the scope of the MRV and transparency mechanism best suited for Viet Nam, including all transparency related to targets and budget on mitigation, adaptation, and finance. Produce a report on the Scope of the MRV and transparency mechanism best suited for Viet Nam and lead consultation with stakeholders.
- 5. Develop draft PIF according to the template as attached in Annex 1.
- 6. Lead the consultations on draft PIF with government, UNDP, and other relevant stakeholders and incorporate comments/suggestions during the mission to Ha Noi.
- 7. Finalize the PIF for submission to UNDP and the Government.
- 8. Support to provide written responses to comments received from GEF Secretariat and revise PIF based on GEF comments.
- 9. Finalize Social and Environment Screening Procedure (SESP, based on UNDP standard guideline)

The *national consultant* (team member) will perform the perform the following tasks:

- 1. Take joint responsibility with the international consultant in preparing and finalizing the PIF and the Report
- 2. Based on advice and guidance by international consultant, collect, review and analyze relevant literature and documents to identify current situation in Viet Nam regarding climate change related MRV systems, gaps/needs of necessary data/information for preparation of the PIF. Specific aspects of data/information include, but not limited to:
 - I. Legal framework and policy including national priorities and strategies and roadmap for Viet Nam's commitment to the Paris Agreement, NDC, UNFCC, and transparency, also including Viet Nam's NC, SNC, BUR (2014; 2017).
 - II. Collate information on barriers and root causes facing Viet Nam regarding the institutional and technical capacity to meet transparency requirements in the Paris Agreement and the improvement of transparency over time.
 - III. Provide Viet Nam specific baseline information, data, and detailed information on ongoing and future related programmes, projects and activities related to transparency and MRV related to mitigation and adaptation, which include but may not be limited to the information of project owners, donors, scopes and expected results and impacts, etc.
 - IV. Suggest relevant interventions (i.e. activities) by the project in terms of policy, capacity building, awareness raising, training, technology transfer and testing of technology, etc. as part of the CBIT.
 - V. Identify key stakeholders and their present and future role in designing and implementing the CBIT project in Viet Nam
 - VI. Assist the international consultant to prepare the project budget and identify project cofinanciers and facilitate to obtain co-financiers.

- 3. Produce Needs and Gaps Analysis on areas that need support, including capacity building and technical inputs and on current transparency /MRV mechanisms in place.
- 4. Provide Summary Note that includes the above-mentioned information/data used as inputs to the formulation of the PIF.
- 5. Support International Consultant in providing written comments and revisions on the draft and final PIF.

4. Duration of assignment, duty station and Expected places of travel

The duration of the assignment is from August 2018 to December 2018.

- International Consultant: 12 days, including 5-day mission to Ha Noi, Viet Nam.
- National Consultant: 15 days

Duty Station: Home-based and Ha Noi. In case of travel to the field/provinces (if required), separate travel arrangement including DSA will be made by UNDP basing on the UN-EU cost norm.

The international bidders must include travel costs in their financial proposal.
