### 5 Financial Proposal

Applicants meeting the minimum requirements listed in the Terms of Reference will be short-listed and asked for price proposals. The selection of the Consultant will be made in accordance with the quality-cost based selection method (70% technical component of which 49% shall consist of the minimum requirements 10% shall consist of the assets and 11% shall consist of the interview score along with a 30% price component).
