1. BACKGROUND

UNDP Indonesia has systematically supported the Government of Indonesia in tackling environment related crimes since the beginning of reformation era. Lessons learned over the years have pointed out that weak law enforcement in the environment sector is best addressed with the use of a Multi-Door Approach. This approach was launched by the Government in 2012 under the name "Multi-Door Approach to address environment related crimes in forest areas and peatlands" (hereinafter referred to as the "Multi-Door Approach") and is seen as a major breakthrough in handling environment related crimes in forest areas and peatlands.

In principle, the Multi-Door Approach can be understood as law enforcement authorities working together on crimes that are related to each other and can therefore be combined, such as a case of illegal logging, forest and peat fires that is related to money laundering and bribery. With the use of various regulations, including regulations related to the environment, forestry, mining, taxation, money laundering, corruption, agriculture and taxation, these crimes can be investigated from multiple angles, leading to a stronger case and more effective law enforcement. The approach is expected to:

- Minimize the possibility of perpetrator's "escape" from more severe sanctions due to the application of only one regulation or law,
- Sanction the "mastermind" or person financing the crime and ensure corporate
 accountability in order to provide a deterrent effect and maximize returns on state losses
 resulting from these crimes.

A significant step in the process to establish the Multi-Door Approach was marked by the signing of a Memorandum of Understanding (MoU) on 20 December 2012 between the Ministry of Forestry, Ministry of Environment, Ministry of Finance, the Attorney General, the Chief of Police and the Head of the Financial Transaction Analysis and Reporting Centre on 'Improving Law Enforcement Cooperation to Support Sustainable Natural Resources Management in the framework of implementation of REDD+'.

At the Government's request, UNDP Indonesia conducted an initial assessment of recent progress made on the implementation of the Multi-Door Approach in 2015. The assessment looked at the effectiveness, efficiency, institutionalization, adaptability and sustainability of the Multi-Door Approach in various processes of law enforcement pertaining to NRERCs, including inquiry, investigation, collection of evidence, case hearing, pre-prosecution, verdicts and legal remedies.

Meanwhile, each law enforcement agency more or less still carries out investigations and inquiries on their own without coordinating with other relevant offices, ministries or agencies. A relatively high number of penalties were imposed, while many of them were minimal in nature. Several offenders, whose gender should be disaggregated, avoided penalties, significantly reducing the potential deterrent effect of the Multi-Door Approach. Corporate liability for recovery of state loss, including the tax sector, is still minimal. Turning this around could have a positive effect on the

reduction of emissions from forest and peatlands.

To remedy the aforementioned challenges, this project is designed to capacitate the relevant law enforcement institutions who signed the MoU of implementing Multi-Door Approach in countering natural resources and environmental cases, in particular the Ministry of Environment and Forestry, the Attorney General's Office and National Police. It will institutionalize the Multi-Door approach by improving each relevant Multi-Door Agencies' SOP and programme/performance indicators, supporting the handling of joint cases, and providing a Support Facility that will lead to the establishment of the Multi-Door Approach secretariat led by Ministry of Environment and Forestry.

Therefore, "to get back on the right track" and maximize on the above potential, one of the required aspects is redefining and enhancing coordination. Successful implementation of the Multi-Door Approach also requires regular and intensive coordination among law enforcers, experts and agency staff. This coordination is crucial from the very onset of case handling, especially in collecting evidence, during inquiry and investigation, including in relevant hearing(s), pre-prosecution, prosecution, indictment, court decision and execution of court decision.

To support the law enforcement agencies in doing a better coordination in handling natural resources and environmental related cases, UNDP Indonesia would like to hire 1 (one) independent consultant to function as liaison personnel.

2. SCOPE OF WORK, RESPONSIBILITIES AND DESCRIPTION OF THE PROPOSED ANALYTICAL WORK

Under supervision of the Multi-Door National Project Manager and the Technical Advisor for Natural Resources Governance, the consultant is tasked to conduct the following:

- To act under the authority of the Multidoor Secretariat to coordinate any related standards activities;
- shall facilitate communication between natural resources and environmental law enforcement agencies. In so doing, the consultant shall provide advice to the law enforcement agencies on Multidoor's purposes, principles, and projects;
- The consultant is expected to have an up-to-date knowledge of Multidoor and Multidoor research projects including project leadership and the stages of these projects;
- to be active in the implementation of Multidoor Law enforcement effort conducted by the related agencies and attends their key meetings;
- The consultant will support strategic partnerships by providing top-quality advice, facilitating
 effective knowledge management, and providing technical assistance to implement the Multidoor
 approach law enforcement;
- To formulate an effective communication strategy to share best practice and lesson learnt in the implementation of Multidoor approach law enforcement;
- To act as key contact point on behalf of the Multidoor Secretariat;
- To support the needs and aspirations of the multidoor secretariat to drive an increase in sustainable participation; and,
- Responsible for identifying and securing resources needed to deliver the work outlined above.
