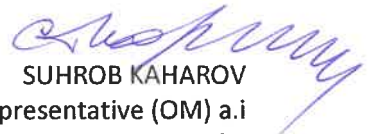

Description of the Key Methods in PIEUAV

1. Fully automatic high-precision registration method for visible optical remote sensing images of drone

The description and detection of local image features can help identify objects. SIFT features are based on the local appearance of interest on the object regardless of the size and rotation of the image. The tolerance for changes in rays, noise, and some minor angles of view is also quite high. Based on these characteristics, they are highly significant and relatively easy to retrieve. In a large number of feature databases, it is easy to identify objects with a high correctness. Using the SIFT feature description, the detection rate for partial object occlusion is also quite high, and even at least three SIFT object features are sufficient to calculate the position and orientation of the image. With today's computer hardware performance and the compact feature database, the near real time recognition can be achieved. SIFT is very suitable for fast and accurate matching in the massive databases due to its rich feature information presented.

SIFT algorithm is to find key points (feature points) in different scale spaces and calculate the direction of key points. The key points found by SIFT are some very salient points that will not change due to light, affine transformations, and noise, such as corner points, edge points, bright spots in dark areas, and dark spots in bright areas. The SIFT algorithm is characterized by its stability, uniqueness, versatility, high speed, and scalability.

2. Large-scale automatic aerial triangulation method based on sparse matrix

The number of non-zero elements in the matrix is much smaller than the total number of matrix elements, and the distribution of non-zero elements is not regular, then the matrix is called a sparse matrix. The difference is that if there is a regular distribution of non-zero elements (such as triangular matrix, lower triangular matrix, symmetrical matrix), then the matrix is called a special matrix.

It is much fast to calculate sparse matrix because MATLAB only operates non-zero elements, which is a salient advantage of sparse matrix. Assume that matrix in matrix A and B are the same. Calculating $2 \times A$ requires one million floating-point operations while calculating $2 \times B$ requires only 2,000 floating-point operations. Because MATLAB cannot automatically create sparse matrix, special commands are used to obtain sparse matrix. For a sparse matrix A_{mn} stored in a two-dimensional array, if it is assumed that each array element needs to store L bytes, $m \times n \times L$ bytes are needed to store the entire matrix. However, most of these storage spaces store element 0, resulting in a lot of space waste. To save storage space, only non-zero elements can be stored. For each element a_{ij} of the matrix A_{mn} , knowing its row number i and column number j can determine its position. Therefore, for a sparse matrix, a node can be used to store a non-zero element.

3. Automatic extraction of dense Digital Surface Model(DSM)

The input of stereo vision matching is the image collected by several cameras with different viewing angles, the output is the corresponding relation of points on these images. c and c' are the optical centers of the two cameras, f is the focal length, and B is the line connecting the two optical centers, also known as the baseline. The line that passes through the optical center and is perpendicular to the image plane is called the optical axis. Standard configuration means that the optical axis of two cameras is perpendicular to the baseline and parallel to each other. Assuming that the focal lengths of the two cameras are equal, and the horizontal coordinate of the camera coordinate system is parallel to the baseline direction, the image formed by the space point P on the two cameras has the same vertical coordinate. This feature is also called epipolar line constraint of stereo vision. Epipolar line refers to the intersection of the epipolar plane and the image plane, where the epipolar plane is containing two focal points and spatial point. For general configuration cameras, the image in the standard configuration can be obtained by camera calibration and registration.

When the baseline and focal length are fixed, that is, the parameters of the camera, the relative position and orientation between the cameras are fixed, the parallax is inversely proportional to the depth of the points in space. Therefore, it is only necessary to know the parallax to obtain the depth of the object, so the stereoscopic vision matching can be defined as solving the parallax according to the images from different cameras.

4. Seamless Image Mosaic

In order to mosaic a large number of ortho-photoimages automatically, we adopt the method of automatic generation and optimization of Voronoi graph seam line network in overlapping areas. When generating the seam line network, this method first generates the global initial seam line network based on the overlap region Voronoi graph, and then uses the image content of the overlap region for optimization. The seam line network divides each ortho-image coverage into effective mosaic polygons. This division is unique, non-redundant, and seamless. The algorithm is parallel, and the effective mosaic polygons of each ortho-image are only related to the overlapped ortho-image. The application of the seam line network ensures the flexibility and efficiency of the mosaic processing, so that the mosaic processing can obtain the final mosaic result directly and avoid the generation of intermediate results, which is irrelevant to the order of the images and is very suitable for a wide range of seamless image mosaic processing.

While searching for optimal seam line automatically, the seam line can be manually modified so that the quality of the image mosaic can be controlled by manual interaction. In order to achieve the consistency of the hue, the feather template is adopted to process the hue of the mosaic image.

General Terms and Conditions

1. ACCEPTANCE OF THE PURCHASE ORDER

This Purchase Order may only be accepted by the Supplier's signing and returning an acknowledgement copy of it or by timely delivery of the goods in accordance with the terms of this Purchase Order, as herein specified. Acceptance of this Purchase Order shall effect a contract between the Parties under which the rights and obligations of the Parties shall be governed solely by the terms and conditions of this Purchase Order, including these General Conditions. No additional or inconsistent provisions proposed by the Supplier shall bind UNDP unless agreed to in writing by a duly authorized official of UNDP.

2. PAYMENT

- 2.1 UNDP shall, on fulfillment of the Delivery Terms, unless otherwise provided in this Purchase Order, make payment within 30 days of receipt of the Supplier's invoice for the goods and copies of the shipping documents specified in this Purchase Order.
- 2.2 Payment against the invoice referred to above will reflect any discount shown under the payment terms of this Purchase Order, provided payment is made within the period required by such payment terms.
- 2.3 Unless authorized by UNDP, the Supplier shall submit one invoice in respect of this Purchase Order, and such invoice must indicate the Purchase Order's identification number.
- 2.4 The prices shown in this Purchase Order may not be increased except by express written agreement of UNDP.

3. TAX EXEMPTION

- 3.1 Section 7 of the Convention on the Privileges and Immunities of the United Nations provides, inter alia, that the United Nations, including its subsidiary organs, is exempt from all direct taxes, except charges for utilities services, and is exempt from customs duties and charges of a similar nature in respect of articles imported or exported for its official use. In the event any governmental authority refuses to recognize UNDP's exemption from such taxes, duties or charges, the Supplier shall immediately consult with UNDP to determine a mutually acceptable procedure.

The Supplier also warrants that the goods are contained or packaged adequately to protect the goods.

7. INSPECTION

7.1 UNDP shall have a reasonable time after delivery of the goods to inspect them and to reject and refuse acceptance of goods not conforming to this Purchase Order; payment for goods pursuant to this Purchase Order shall not be deemed an acceptance of the goods.

9. RIGHTS OF UNDP

In case of failure by the Supplier to fulfil its obligations under the terms and conditions of this Purchase Order, including but not limited to failure to obtain necessary export licences, or to make delivery of all or part of the goods by the agreed delivery date or dates, UNDP may, after giving the Supplier reasonable notice to perform and without prejudice to any other rights or remedies, exercise one or more of the following rights:

9.1 Procure all or part of the goods from other sources, in which event UNDP may hold the Supplier responsible for any excess cost occasioned thereby.

9.2 Refuse to accept delivery of all or part of the goods.

9.3 Cancel this Purchase Order without any liability for termination charges or any other liability of any kind of UNDP.

10. LATE DELIVERY

Without limiting any other rights or obligations of the parties hereunder, if the Supplier will be unable to deliver the goods by the delivery date(s) stipulated in this Purchase Order, the Supplier shall (i) immediately consult with UNDP to determine the most expeditious means for delivering the goods and (ii) use an expedited means of delivery, at the Supplier's cost (unless the delay is due to Force Majeure), if reasonably so requested by UNDP.

11. ASSIGNMENT AND INSOLVENCY

11.1. The Supplier shall not, except after obtaining the written consent of UNDP, assign, transfer, pledge or make other disposition of this Purchase Order, or any part thereof, or any of the Supplier's rights or obligations under this Purchase Order.

11.2. Should the Supplier become insolvent or should control of the Supplier change by virtue of insolvency, UNDP may, without prejudice to any other rights or remedies, immediately terminate this Purchase Order by giving the Supplier written notice of termination.

12. USE OF UNDP OR UNITED NATIONS NAME OR EMBLEM

The Supplier shall not use the name, emblem or official seal of UNDP or the United Nations for any purpose.

13. PROHIBITION ON ADVERTISING

The Supplier shall not advertise or otherwise make public that it is furnishing goods or services to UNDP without specific permission of UNDP in each instance.

14. CHILD LABOUR

The Supplier represents and warrants that neither it nor any of its affiliates is engaged in any practice inconsistent with the rights set forth in the Convention on the Rights of the Child, including Article 32 thereof, which, inter alia, requires that a child shall be protected from performing any work that is likely to be hazardous or to interfere with the child's education, or to be harmful to the child's health or physical, mental, spiritual, moral or social development.

15. MINES

The Supplier represents and warrants that neither it nor any of its affiliates is actively and directly engaged in patent activities, development, assembly, production, trade or manufacture of mines or in such activities in respect of components primarily utilized in the manufacture of Mines. The term "Mines" means those devices defined in Article 2, Paragraphs 1, 4 and 5 of Protocol II annexed to the Convention on Prohibitions and Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects of 1980.

Any breach of this representation and warranty shall entitle UNDP to terminate this Purchase Order immediately upon notice to the Supplier, without any liability for termination charges or any other liability of any kind of UNDP.

16. SETTLEMENT OF DISPUTES

16.1 Amicable Settlement. The Parties shall use their best efforts to settle amicably any dispute, controversy or claim arising out of, or relating to this Purchase Order or the breach, termination or invalidity thereof. Where the Parties wish to seek such an amicable settlement through conciliation, the conciliation shall take place in accordance with the UNCITRAL Conciliation Rules then obtaining, or according to such other procedure as may be agreed between the Parties.

16.2 Arbitration. Unless, any such dispute, controversy or claim between the Parties arising out of or relating to this Purchase Order or the breach, termination or invalidity thereof is settled amicably under the preceding paragraph of this Section within sixty (60) days after receipt by one Party of the other Party's request for such amicable settlement, such dispute, controversy or claim shall be referred by either Party to arbitration in accordance with the UNCITRAL Arbitration Rules then obtaining, including its provisions on applicable law. The arbitral tribunal shall have no authority to award punitive damages. The Parties shall be bound by any arbitration award rendered as a result of such arbitration as the final adjudication of any such controversy, claim or dispute.

17. PRIVILEGES AND IMMUNITIES

Nothing in or related to these General Terms and Conditions or this Purchase Order shall be deemed a waiver of any of the privileges and immunities of the United Nations, including its subsidiary organs.

18. SEXUAL EXPLOITATION:

18.1 The Contractor shall take all appropriate measures to prevent sexual exploitation or abuse of anyone by it or by any of its employees or any other persons who may be engaged by the Contractor to perform any services under the Contract. For these purposes, sexual activity with any person less than eighteen years of age, regardless of any laws relating to consent, shall constitute the sexual exploitation and abuse of such person. In addition, the Contractor shall refrain from, and shall take all appropriate measures to prohibit its employees or other persons engaged by it from, exchanging any money, goods, services, offers of employment or other things of value, for sexual favors or activities, or from engaging in any sexual activities that are exploitive or degrading to any person. The Contractor acknowledges and agrees that the provisions hereof constitute an essential term of the Contract and that any breach of this representation and warranty shall entitle UNDP to terminate the Contract immediately upon notice to the Contractor, without any liability for termination charges or any other liability of any kind.

18.2 UNDP shall not apply the foregoing standard relating to age in any case in which the Contractor's personnel or any other person who may be engaged by the Contractor to perform any services under the Contract is married to the person less than the age of eighteen years with whom sexual activity has occurred and in which such marriage is

recognized as valid under the laws of the country of citizenship of such Contractor's personnel or such other person who may be engaged by the Contractor to perform any services under the Contract.

19.0 OFFICIALS NOT TO BENEFIT:

The Contractor warrants that no official of UNDP or the United Nations has received or will be offered by the Contractor any direct or indirect benefit arising from this Contract or the award thereof. The Contractor agrees that breach of this provision is a breach of an essential term of this Contract.

20. AUTHORITY TO MODIFY:

Pursuant to the Financial Regulations and Rules of UNDP, only the UNDP Authorized Official possess the authority to agree on behalf of UNDP to any modification of or change in this Agreement, to a waiver of any of its provisions or to any additional contractual relationship of any kind with the Contractor. Accordingly, no modification or change in this Contract shall be valid and enforceable against UNDP unless provided by an amendment to this Agreement signed by the Contractor and jointly by the UNDP Authorized Official.
