Summary of proposal:

UNDP Belgium has been identified as the Leading Agency to organize and conduct the bidding process on behalf of UN/UNDP, UNCDF, UN Habitat, UNFPA, UNODC, UNIDO, OHCHR, UNISDR, UN Environment Programme, UN Women, UNOPS, UNICRI, UNDP ART, UNDP GPECS, UNDP LVMM and UNOPS Cities Alliance.

UNDP Belgium hereby invites companies to express their interest and provide requested supporting information to demonstrate their eligibility to participate in upcoming bidding exercise for the security enhancements of the new UN House Premises.

The above-mentioned UN Agencies are looking to move to new premises. The new UN House building will need to comply with the minimum operational security standards – MOSS.

The Contractor shall provide the following goods/services fitted as per UN Guideline and in accordance with EU/US standards:

- Integrated security system solution for the new UN House premises (namely for the occupied floors in a multi-tenant building), such as hardware:
 - Surveillance CCTV Monitoring System
 - Security doors
- And software:
 - ➤ Electronic security system
 - Access control
 - Service system for emergency response

Outputs:

Provision and installation of UN House security enhancements.

- A company profile outlining its management approach and structure, range of services provided
- Copies of relevant international certification (such as ISO 27001 / ISO 9001, etc.), accreditation or membership of international standards organizations, as well as copies of current third party/liability insurance applicable to the company's clients.
- A list of current top three to five clients and size and general scope of the contracts
- Contract supervisory structure, client communication approach and quality assurance methodology
- Unique Service/Innovation/Other elaborate on the elements which you deem to be the outstanding selling points for your company. What are you providing or doing differently than your competitors? Why should the UN consider your company above all the others?
- Service Branch/Representative presence in Belgium is an asset.

Companies will be selected in accordance with the procedure set out in the UNDP Procurement Guidelines and UNDP Financial Rules and Regulations.
