1. BACKGROUND

The Social and Environmental Compliance Unit (SECU) is UNDP's social and environmental compliance review mechanism, conducting independent investigations to ensure UNDP adheres to its own social and environmental standards and procedures, in particular the Social and Environmental Standards (SES).

The SES apply to all UNDP projects, programmes, and activities. SECU is housed within the Office of Audit and Investigations (OAI) and forms one of the two units that comprise UNDP's Accountability Mechanism, the other being a dispute resolution function located in headquarters' programmatic management team.

SECU seeks to engage in a three years Long-Term Agreement (LTA) suitably skilled and experienced analysts (maximum 3 consultants) to assist with its growing case load, research, outreach and communications needs, logistics support, and to increase its linguistic coverage. This work includes researching topics connected to its cases, reviewing documents/intake/communications, assisting in communications with stakeholders, translating and interpreting documents (based on consultants' linguistic skills), taking notes in meetings, assisting and conducting outreach to stakeholders, and assisting in other tasks related to SECU's general operations. The consultants will be called upon as required from time to time.

2. SCOPE OF WORK, RESPONSIBILITIES AND DESCRIPTION OF THE PROPOSED ANALYTICAL WORK

Scope of work

Under the supervision of the SECU Unit Coordinator /Research Analyst, OAI, the Individual Consultant will undertake the following activities:

- Conducts research and writing for SECU and OAI.
- Provides logistical support to SECU and OAI.
- Facilitates communications among SECU, OAI and individuals, including through coordinating weekly update conference calls and liaising with case stakeholders.
- Contributes to the development of the SECU website and other outreach activities.
- Handles intake, processing, evidence gathering/analysis, and other tasks connected to potential and eligible SECU cases.

Expected outputs:

Under the supervision of the SECU Unit Coordinator/Research Analyst the Individual Consultant will be required:

- Plan and conduct research and analysis of information pertaining to SECU Compliance Review cases to contribute to their completion in the form of memos and contributions to reports, guidelines, and papers;
- Plan and support in communications/outreach efforts, including creating newsletters, web designs, event planning, and other communications outputs in the form of web pages, outreach campaigns, newsletters, etc;
- Translate documents/interpret meetings as needed, based on language skills, into and from English;
- Take notes, maintain records, and generally contribute to the organizational tasks of SECU.

3. REQUIREMENTS FOR EXPERIENCE AND QUALIFICATIONS

Qualifications:

I. Minimum eligibility requirements:

- Advanced university degree in international affairs, international relations, international
 development, human rights, environmental conservation/science, anthropology, law,
 communications, economics, sociology, or other related field, is required;
- 2 years professional work experience in communications, research, and/or operations at an international public or private organization with locations in multiple countries, is required;
- Experience in evaluation, corporate social responsibility, social & environmental compliance/audit/investigation, is required;

• Fluency in oral and written English is required.

II. Qualification to be evaluated during CV review:

- Working experience with an independent social and environmental accountability mechanism, is highly desirable;
- Working experience with independent social and environmental investigations, is highly desirable;
- Working experience with human rights, environmental protection, gender equality, indigenous peoples' rights, labor law/policy, pollution prevention, and/or FPIC, is highly desirable;
- Demonstrated research, writing, coordinating, and organizational skills;
- Ability to use and apply the following technical process of aides:
 - Graphic and web design software
 - Microsoft Office Suite
 - Social Media and Open Sources
- Fluency in oral and written Spanish, Arabic, or French, is highly desirable;
- Fluency in oral and written Portuguese, Russian, Swahili, Malay/Bahasa, Chinese, Burmese, Vietnamese, Bengali, or Hindi, is desirable.

Demonstrates ability to perform in accordance with relevant professional standards for administrative investigations.

The individual consultant should be able to draft and edit documents in word and excel in English. Have excellent computer skills. Demonstrates ability to use and apply the following technical process of aides, in order to improve the efficiency and effectiveness of SECU operations:

- Social Media and Open Sources

- 3. **Financial proposal:** indicating the proposed daily fee rate in US\$ and using the Financial Proposal form provided in Annex 4.

5. FINANCIAL PROPOSAL

The Price Proposal should be fixed and "all-inclusive" daily rate. This means that all costs (professional fees and other related costs such as communication, insurance, etc., if any) are included in the daily fee.

The financial proposal submitted by the applicants shall remain in effect for the period of 3 years of LTA.

Payment Terms

The consultancy fee will be paid per working day.

Payment will be made upon:

- Submission of invoices and support documentation, specifying the number of working days worked and documentation to support pre-approved expenses.
- Certification of the SECU Unit Coordinator / Research Analyst.

Travel

As and when travel for business purposes is required, OAI will notify the consultant and agree upon the reimbursable travel costs including tickets, lodging and terminal expenses as per UNDP Policy on Individual Consultants.

6. EVALUATION

Selection of applicants for awarding Long Term Agreements:

Individual consultants will be evaluated based on the Cumulative Analysis. The award of the LTA will be made to the individual consultant whose offer has been evaluated and determined as:

- a) Responsive/compliant/acceptable, i.e. complete and met the minimum eligibility requirements, and
- b) Having received the highest score out of pre-determined set of weighted technical and financial criteria specific to the solicitation.
 - Technical Criteria weight: 70%
 - Maximum top 8 candidates who obtained a minimum of 18 out of 30 CV points will be invited for written test.
 - Maximum top 5 candidates who scored minimum 14 out of maximum 20 points for written test will be interviewed.
 - o Candidates who obtained a minimum of 49 out of 70 technical points will be considered for the Financial Evaluation.
 - Financial Criteria weight: 30%

• The maximum number of points assigned to the financial proposal is allocated to the lowest price proposal. All other price proposals receive points in inverse proportion

The Individual Consultant will be engaged on an 'as needed' basis. When OAI requires the services of one or more contract analyst(s), a selection will be made from LTA roster according to -the required skills, language abilities;

-value for money of contract analyst. This is based on the proposed daily rate of the applicants.

The selected consultant will be awarded an Individual Contract (IC) with specific TOR on investigations cases and duration.
