1. Title

Supply, delivery and installation of a total of one flour-milling complex in Nerkin Tsaghkavan community of Tavush Marz.

2. Project Title

"Integrated Support to Rural Development: Building Resilient Communities" project.

3. Project Description

"Integrated Support to Rural Development: Building Resilient Communities" is implemented in borderline communities of Tavush Region of the Republic of Armenia with the financial support of the Russian Federation. The overall goal of the project is to ensure balanced development of Tavush region of RA through an integrated socio-economic approach. The project aims at raising the quality of life and income level of the local population in 45 bordering communities of Tavush region.

4. Scope of Work

Within the scope of "Integrated Support to Rural Development: Building Resilient Communities" project supply, deliver and install in total of one flour-milling complex for Joint Communities Development Fund of Sarigyugh - Nerkin Tsaghkavan cluster of communities (located in administrative territory of Nerkin Tsaghkavan community) of Tavush Marz.

5. Technical specifications of flour-milling complex

The flour-milling complex should be from the manufacturers' standard range of production and current supply, brand new and guaranteed from all type of defects. All equipment and parts should be fully assembled with standard fittings, tested and ready for immediate use.

The flour-milling complex should consist from the following parts:

Grain cleaning aggregate which should consist from the following units:

- Grain washer unit
- Cup elevator (noria); designed for vertical transportation of grain
- Grain cleaning unit (grain separator); designed for grain crops cleaning from coarse, fine and light impurities
- Grain surface cleaning unit (hulling machine); designed for cleaning the surface of grains of mineral impurities, partial removal of barbs, the embryo and torn envelopes
- Humidifying unit; designed for moistening of grain
- Air purification unit; designed for grain cleaning from impurities which differ in their aerodynamic qualities
- Aspiration columns; intended to separate the impurities from the grain products separation flaking cereals differing aerodynamic properties
- Magnetic separator; designed for separation of grain and its products from metallic magnetic impurities from steel
- Tank for softening of grain
- Stone separator

Mill aggregate which should consist from the following units:

- Rolling unit (used for grinding of grain)
- Pneumatic conveying unit
- Dressing unit
- Packing unit
