

Call for Proposals from NGO/CSOs

I. BACKGROUND

UNDP partners with people at all levels of society to help build nations that can withstand crisis, and drive and sustain the kind of growth that improves the quality of life for everyone. On the ground in 177 countries and territories, we offer global perspective and local insight to help empower lives and build resilient nations

This Call for Proposals (CFP) is specifically related to the UNDP project, **Human Trafficking and terrorism:** Countering vulnerability to human trafficking in violent extremism in Southeast Asia.

II. OBJECTIVES AND EXPECTED OUTPUTS/ DELIVERABLES

The objective of this Call for Proposals is to support the ongoing work of UNDP. In this regard, the selected NGO/CSO will focus its efforts on several activities:

- 1. Collecting and gathering data examining the potential vulnerability to human trafficking through terrorism in Indonesia, and providing inputs to the analysis as required;
- 2. In line with the outcomes of the study, facilitating a forum with ASEAN country representatives on addressing human trafficking and terrorism;
- 3. In line with the outcomes of the study, developing awareness raising materials with civil society on risks associated with TIP and extremism;
- 4. In line with the outcomes of the study, conducting a workshop with relevant national stakeholders to identify and investigate potential trafficking cases related to terrorist groups.

Detailed objective and related outputs and deliverables are provided in the Terms of Reference - Annex 1

III. ELIGIBILITY & QUALIFICATION CRITERIA

The parameters that will determine whether a <u>NGO/CSO is eligible</u> to be considered by UNDP will be based on the <u>NGO/CSO Request for Information (RFI)</u> template.

It is expected that the NGO/CSO will meet the following qualifications:

- Experience in the area of violent extremism and human trafficking;
- Experience in conducting research and policy advocacy;
- Experience in working with governments in Indonesia and the broader ASEAN region;
- Excellent written and verbal communication skills in English and Indonesian.

IV. PROPOSAL

<u>Proposed methodology, approach, quality assurance plan and implementation plan</u> – this section should demonstrate the NGO/CSO's response to the Terms of Reference by identifying the specific components proposed, how the outputs/deliverables shall be addressed, as specified; providing a detailed description of the essential performance characteristics proposed; identifying the works/portions of the work that will be subcontracted.

Moreover, the proposal should demonstrate how the proposed methodology meets or exceeds the TOR, while ensuring appropriateness of the approach to the local conditions and the rest of the project operating environment. This methodology must be laid out in an implementation timetable and a quality assurance plan.

<u>Management Structure and Resource (Key Personnel)</u> – This section should include a comprehensive description of the management structure and information regarding required resources including curriculum vitae (CVs) of key personnel that will be assigned to support the implementation of the proposed methodology, clearly defining the roles and responsibilities vis-à-vis the proposed methodology. CVs should establish competence and demonstrate qualifications in areas relevant to the TOR.

V. EVALUATION CRITERIA & METHODOLOGY

Budget size and duration

Proposal amounts should be a maximum of **USD.** *67,500* for all activities as stated in the ToR. The total amount quoted shall be all-inclusive and include all costs required to produce the deliverables identified in the TOR, including professional service fee, and any other applicable costs to be incurred by the contractor in completing the assignment. The contract price will be a fixed, output-based price regardless of any extension of the herein specified duration. It is suggested that the budget should follow approximate calculation:

The management cost should not exceed 20% of the total budget proposed. The amount requested in the proposal should be commensurate with the organization's administrative and financial management capabilities. In principle, project duration will not exceed [6] months from September 2018 to February 2019.

Payment will be made upon the satisfactory delivery of outputs, as certified by Syamsul Tarigan, UNDP Indonesia, in consultation with UNDP BRH.

VI. SELECTION PROCESS:

UNDP will review proposals through a five-step process: (i) determination of eligibility; (ii) technical review of eligible proposals; (iii) scoring and ranking of the eligible proposals based on the assessment criteria outlined in the previous section to identify the highest ranking proposal; (iv) round of clarification (if necessary) with the highest scored proposal; and (v) Micro-grant Agreement signature

VII. SUBMISSION PROCESS

Applicants shall bear all costs related to proposal preparation and submission.

Terms of Reference

NGO/CSO Support for Project Implementation in Indonesia Project: Human Trafficking and terrorism: Countering vulnerability to human trafficking in violent extremism in Southeast Asia

A. Background Information

Links between human trafficking and terrorism are not new, however the changing nature of violent extremism are exacerbating forms of trafficking. These trends are a global threat to peace and security, with extremists using trafficking as part of an ideology as well as for the recruitment and financing of activities. The establishment and activities of groups such as ISIS, AI-Qaeda, Boko Haram and AI-Shabaab in the Middle East and Africa are having implications well beyond those regions, and have resulted in a range of trafficking patterns as part of their ideology. Beyond the enslavement of populations that come under the control of terrorist groups such as ISIS, or IS), human trafficking is used as a tool in the 'recruitment and retention of male foreign fighters and provides a reward mechanism for successful combatants'¹.

The situation in Southeast Asia, with a prevalence of trafficking in persons and an increasing presence of extremist groups, needs to be proactively and preemptively addressed. The threat of violent extremism spreading in Indonesia, Malaysia, the Philippines, Bangladesh and Myanmar, has been a growing concern in the region due to signals from terrorist groups in the region and those such as IS and Al-Qaeda internationally. The efforts to combat ISIS in Syria and Iraq has resulted in different strategies adopted by ISIS to recruit members and launch attacks elsewhere, with Southeast Asia becoming a focus of target for expansion².

The expansion of ISIS ideology is starting to take a root in Southeast Asia, and this may increase as foreign fighters return from the Middle East to Indonesia and Malaysia. Recent propaganda (August 2017) from ISIS called on foreign fighters to support the Maute group in the Philippines, and the links between this and other groups in the region makes this an urgent threat to stability and peace in the Southeast Asia. While the Maute group may no longer be a destination for fighters, motivations may remain to join another group in the region, while several Islamist groups have also called for an offensive Myanmar, including those from Indonesia³.

ISIS ideology is closely linked to human trafficking, going beyond using it for funding and recruitment purposes. In Marawi, there are indications that hostages were forced to fight and were also guarded by child soldiers, also a form of trafficking. It is therefore urgent to better understand what populations may be vulnerable to human trafficking as a result of this expansion and how this can be immediately addressed.

Under this backdrop, the project aims to (1) Develop an in-depth understanding of vulnerability to human trafficking related to terrorism in Southeast Asia; and (2) Build capacities to respond to human trafficking related to terrorism, at policy and operational levels. The proposed objective(s) will be achieved by the following outputs through these activities and actions:

- 1. Increased evidence base on the threats of violent extremism and terrorism-related human trafficking in the region, the types of trafficking and perpetrators involved.
 - 1.1. Research on vulnerability to human trafficking through terrorism in Southeast Asia, focused on two target countries: Philippines and Indonesia.
 - 1.2. Development of typology of trafficking related to terrorism to demonstrate and understand the linkages, by extremist group and type of trafficking.

- 1.3. Identify vulnerabilities to trafficking by terrorist group in the target countries.
- 2. Policy advocacy based on the research to inform policy dialogue with the two governments engaged, as well as in Southeast Asia, to proactively address risks of extremism-related human trafficking.
 - 2.1. Develop policy guide on addressing human trafficking and terrorism in Southeast Asia.
 - 2.2. Facilitate a forum with ASEAN country representatives on addressing human trafficking and terrorism.
 - 2.3. Provide specific policy advice to affected (and potentially affected) governments on addressing human trafficking related to terrorism.
- 3. Capacities of national authorities and civil society built to gather and share information and intelligence on trafficking related to terrorism, and inform prevention interventions at local, national and regional levels.
 - 3.1. Develop awareness raising materials with civil society on risks associated with trafficking and terrorism.
 - 3.2. Conduct workshops with relevant authorities to identify and investigate trafficking cases related to terrorist groups.

B. Scope of Work and Expected Results

The above components will be implemented through a mix of interventions by different stakeholders, both regionally and nationally. In Indonesia, the NGO/CSO will focus its efforts on the following activities:

- 1. Collecting and gathering data examining the potential vulnerability to human trafficking through terrorism in Indonesia, and providing inputs to the analysis as required;
- 2. Facilitating a forum with ASEAN country representatives on addressing human trafficking and terrorism;
- 3. In line with the outcomes of the study, developing awareness raising materials with civil society on risks associated with TIP and extremism;
- 4. In line with the outcomes of the study, conducting a workshop with relevant national stakeholders to identify and investigate potential trafficking cases related to terrorist groups.

C. Research

The NGO/CSO will conduct in-country interviewing and data gathering, in support of a big data and weak-signal analysis examining the nexus between violent extremism and human trafficking in Indonesia. With support from UNDP Indonesia and BRH, the scope of the work is:

- Develop a research plan for interviewing and data gathering, including stakeholders for primary data collection and sources for secondary data;
- Conduct key informant interviews and/or focus group discussions with both governmental and nongovernmental experts on violent extremism and/or human trafficking;
- Gather relevant secondary data, both traditional and non-traditional, with a focus on sources not currently accessible online;
- Compile an organized set of key informant interview and/or focus groups discussion write-ups including separate, overall analytical notes.

The final product of the research will include:

- 1) Research plan as agreed with UNDP;
- 2) Organized set of write-ups for key informant interviews and/or focus groups discussions, with separate, overall analytical notes;

3) A package of secondary data including a directory of source.

The researcher(s) is/are expected to have the following qualifications:

- Education: Master's Degree or higher in conflict or security studies, political science, migration or related fields
- Experience:
 - At least 10 years of experience working in research on violent extremism, conflict or security, ideally with some knowledge of human trafficking and related issues;
 - Proven knowledge of the political, economic, social conditions in Southeast Asia;
 - Excellent relationships with governmental and non-governmental counterparts;
 - Outstanding report and interview writing skills;
 - Knowledge of quantitative and qualitative research methods an asset
- Language: Fluency in written and spoken English

D. Institutional Arrangement

The selected NGO/CSO will work closely with focal points from UNDP Bangkok Regional Hub, UNDP Indonesia Country Office, and government stakeholders. In addition, the selected NGO/CSO is responsible for the submission of the expected deliverables according to the above proposed timeline. Each deliverable must receive a technical clearance from UNDP in Indonesia, the Team Leader of the Democratic Governance and Poverty Reduction Unit (DGPRU) that is based in Jakarta.

The NGO/CSO is further expected to remain in close communications with DGPRU Project Coordinator for this project in providing regular updates through verbal or written communication. DGPRU will work with the NGO/CSO to ensure transparency and accountability of the micro-capital grant to be presented to the NGO/CSO. DGPRU expects the NGO/CSO to be responsive to UNDP requests that are aligned with the overall objectives of the project. Lastly, the NGO/CSO is expected to present reports, results, findings to various audiences as required/requested.

E. Duration of Assignment

The selected organization will undertake this assignment for 6 months, from September 2018 to February 2019.

F. Location of Assignment

The selected organization will work in Jakarta and other areas, ensuring effective coordination and facilitation of activities. The organization will be responsible to remain in regular communications with focal points from UNDP Bangkok Regional Hub, UNDP Indonesia Country Office, and government stakeholders.
