II. Inquiries/Questions/Clarifications:

We are pleased to provide you our official response for the queries received through e-mail.

Question 1:

There is an apparent inconsistency between two items:

- a) the RFP document "PHL-RFP-2018-062", page 27, seems to require the Bid Security to be issued by the Bidder and deposited by means of a certified check in a bank account.
- b) The document "PREMS_RFP-062_Editable_Forms" contains the Form H "Form of Proposal Security" that represents a template of a usual bank guarantee undersigned by a guarantor bank.

Answer 1:

Please be informed that the bidder has the <u>option to use either Bid Security forms. The Bid Security may be in the form of a Certified Check/Managers Check or Form H-Proposal Security/Bank Guarantee.</u> Both bid security forms should be issued by a reputable bank.

Clarifications:

1. The Performance Security in the value of 10% of the contract price is to be valid until satisfactory completion and submission of due deliverables per RFP Pages 65-66. It is not required to be valid for the full 3 years of hardware warranty.

Response: Yes. The validity of performance security should be until the issuance of the satisfactory completion and submission of due deliverables.

2. The Warranty Certificate will be a separate security/bank guarantee, in accordance with the Special Conditions of Contract on RFP Pages 31-32, which the supplier will put in place prior to expiration of the Performance Security.

Response: Yes.

3. The Bid Security in the form of a Certified Check should be in favor of UNDP Representative to the Philippines.

Response: UNDP has different account names depending in the currency if the bid security to be submitted.

o For US Dollar:
