ATTACHMENT-1-ANSWERS TO QUESTIONS FROM PROSPECTIVE PROPOSERS

Question 1: In Form G. Financial Proposal Form, should Task 4 be written as "Survey and investigation report" rather than "Employer's requirement with conceptual design drawings and cost estimate"?

Answer 1: As elaborated in Item D.iii "Employer's requirement with conceptual design drawings and cost estimate" and Item E "Deliverables and Schedules/Expected Outputs" of Section 5. Terms of Reference (ToR), "Survey and investigation report" is placed within the "Employer's requirement with conceptual design drawings and cost estimate" task due to their close relation; whereas it is considered as a separate deliverable due to its unique nature and different due date. Hence, the corresponding Task for Deliverable 4 "Survey and investigation report" is "Employer's requirement with conceptual design drawings and cost estimate".

Question 2: Among the list of non-key personnel mentioned in Section 5. Terms of Reference and Form G. Financial Proposal Form, geotechnical engineer/expert is not included. Should the cost of services to be provided by this staff be included in the "Other Expenses" line of Deliverable 4 "Survey and investigation report" in Form G. Financial Proposal Form?

Answer 2: In the proposed areas where the GSD facility is to be built; a Wastewater Treatment Plant and a landfill site already exists. Thus, the soil investigation reports of the areas are available. As elaborated in Item D.iii "Employer's requirement with conceptual design drawings and cost estimate" of the ToR, any physical work is not expected such as drilling, sampling or testing. The aim is to obtain available soil investigation reports within the survey phase, commencing the observational site investigations and prepare an assessment providing information to be used in conceptual design. Accordingly, "Survey and investigation report" stipulated as Deliverable 4. In Form G. Financial Proposal Form does not necessitate deployment of a geotechnical engineer/expert, which was not included in the list of non-key personnel with the same logic.

Question 3: Is it acceptable to submit proposal security in Turkish?

Answer 3: As per Item 1 of Section 3. "Bid Data Sheet", the language of proposals is English. As per Item 12.1. of Section 2. "Instruction to Bidders", proposal security shall be provided in the amount and form indicated in the BDS. Form H. "Form of Proposal Security" is attached to the RFP document and is in English. Hence, proposal security shall be submitted in English by using Form H. "Form of Proposal Security" attached to the RFP document.

The proposers can submit proposal security in "English <u>and</u> Turkish" with the condition that the English version is exactly the same as Form H. "Form of Proposal Security". Please note that English version governs the process.
