#### A. BACKGROUND

Myanmar has embarked on a major transition towards democracy, market style economy and peace. Myanmar has low middle-income status (LMIC) and is committed to lifting itself out of Least Developed Country (LDC) status within the next seven years. Following the implementation of the first ever UNDP Country Programme during 2013-2017 and as a key development partner of the government of Myanmar, UNDP will implement a new UNDP Country Programme for the period 2018-2022, striving to deliver on a large and relevant Programme portfolio that is responsive to the main development challenges facing the country.

The UNDP Myanmar Sustainable and Inclusive Growth Team anchors UNDP's Programme portfolio in these areas of sustainable and inclusive growth issues (including economic growth, environment, climate change and disaster risk reduction) and provides thought leadership on cross-cutting development issues in Myanmar, and globally, to ensure that UNDP's mandate of convening development partners in support of the national development agenda, informed by a commitment to the 2030 Agenda and the Sustainable Development Goals, is amplified by internal knowledge, research, and stand-out policy advice.

Given the importance of enhancing the local resilience through thematic and practical integration of DRR and CCA in a wider development context of Myanmar, UNDP developed a project concept (PIF) "Reducing Climate Vulnerability of Coastal Communities of Myanmar through an Ecosystembased approach" in collaboration with the Ministry of Natural Resources and Environmental Conservation (MONREC) and in consultations with the relevant line ministries/departments and

Rakhine State Government. The PIF, approved by GEF secretariat, focuses on mainstreaming Ecosystem Based Adaptation (EBA) into local planning processes to foster sustainability transitions.

A Project Preparation Grant (PPG) has been obtained to carry out necessary analyses and prepare the full-fledge project proposal. In order to ensure the results of the project preparation work, UNDP is seeking an international specialist for project development as a PPG Team Leader to produce a project document along with a set of relevant evidence based analyses for submission to the GEF. The approved PIF will be the basis for developing a fully formulated project proposal. The proposed project anticipates activities to;

- 1. Mainstream EBA into sub-national and national development policies, laws, and institutional functions;
- 2. Strengthen the capacities and knowledge of broad stakeholder groups required for employing effective and participatory EBA to enhance the local social and ecological resilience; and
- 3. Link EBA activities to Disaster Risk Reduction (DRR) efforts such as community-based DRR and people-centered Early Warning Systems (EWS) and lessons documentation to be shared with the wider public and stakeholders.

In doing so, the project will introduce EBA as an integral component in the country's approach to climate change adaptation, thereby strengthening recognition of the importance of natural ecosystems for climate change risk management, as well as maintenance of socio-economic benefits and conservation of biodiversity.

### B. SCOPE OF WORK, OUTPUTS AND DELIVERABLES

Under the supervision of the Chief of Unit (Sustainable and Inclusive Growth) and technical support of the UNDP-GEF Technical Advisor, the GEF Project Design Specialist will be the GEF PPG Team Leader and will be responsible for quality assurance and timely preparation of all reports and documentation, including the finalized UNDP Project Document (ProDoc) and CEO Endorsement Request, with all mandatory and project specific Annexes and supporting documentation. S/he will be responsible for coordinating the GEF PPG Team's work and managing all consultants, working closely with M&E and Project Technical Coordinator. S/he will take a lead role in designing project activities that promote EBA drawing on technical analyses of biodiversity threats and conservation needs as well as a quick institutional mapping.

UNDP Myanmar will lead the project development process and manage the GEF PPG budget in full consultation with the UNDP-GEF Technical Adviser. The GEF project preparation team will be composed of the following two international and five national consultants:

- International GEF Project Design Specialist (Team Leader)
- International Disaster Risk Reduction and Climate Change Adaption Specialist
- National Specialist in Project Technical Coordinator and M&E
- National Specialist in Community Based Disaster Risk Management

- Under the overall supervision of Chief of Unit, the International Project Design Specialist will report to the Programme Specialist (Sustainable and Inclusive Growth) of the UNDP Country Office in Myanmar as necessary for administrative purpose and to the Regional UNDP-GEF Advisor, and GRSP Chief Technical Advisor for the technical matters.

#### E. DUTY STATION AND DURATION OF ASSIGNMENT

This consultancy will be home-based and with three travels to Myanmar; any necessary missions must be approved in advance and in writing by the supervisor. The consultancy will be carried out for 60 days during 19 November 2018 – 30 August 2019.

#### F. PAYMENT ARRANGMENT

- (j) Synthesize all analyses, studies, etc. that are prepared under Components A and B to produce the draft UNDP-GEF ProDoc, GEF CEO Endorsement request, and all mandatory and project specific Annexes, using the required templates;<sup>1</sup>

- Knowledge of GEF, UNDP policies, procedures and practices (including Social and Environmental Screening and Gender Analysis) and working experience with international organizations or GEF funded projects is a must (10 points);
- Work experience in Myanmar is an asset (3 points);
- Demonstrated strategic technical and intellectual skills in the substantive area (10 points);
- Demonstrated leadership, facilitation and coordination skills, ability to manage technical teams, conduct inclusive stakeholder consultations, and build long term strategic partnerships (10 points);
- Proven ability to work effectively in multi-disciplinary and multi-cultural teams (4 points);
- Strong interpersonal and written and oral communication skills (4 points); and
- Past track record/Ability to work independently, deliver timely and quality products (4 points)

#### Financial Evaluation of Proposals:

The financial proposals of all the applicants who pass the technical evaluation will be scored. The maximum 30 points will be allotted to the lowest financial bid, and all other bids shall receive points in inverse proportion to the lowest fee e.g. [30 Points] x [USD lowest] / [USD other] = points for other proposer's fees

The contract shall be awarded to the applicant who receives the highest cumulative score.
