Background

Since 2009, Boko Haram violence across the Lake Chad has killed more than 25000 people and forced 2.5 million from their homes. Structural drivers of the conflict, such as lack of development, the impact of climate change and poor governance pre-date, and have been amplified by, the conflict.

In response, Nigeria, Cameroon, Niger, Chad, and Benin, agreed to synergize their military efforts within the framework of the Lake Chad Basin Commission (LCBC), forming the Multi-National Joint Task Force (MNJTF) against Boko Haram. The deployment of the MNJTF was authorized during the 489th meeting of the Peace and Security Council (PSC) of the African Union (AU) on 3 March 2015.

The MNJTF has successfully degraded the group's capacity to wage large scale insurgency. This has led to an increase in the number of individuals leaving Boko Haram, either through voluntary surrender or via capture.

In August 2018, under the aegis of the AU and the LCB Commission, a Regional Strategy on Stabilization was endorsed. In Cameroon, while there is yet no national strategy on the management of persons formerly associated to the Boko Haram, a number of encouraging steps towards stabilization have been made in Cameroon. Surrenderees have been observed in more than 5 municipalities along the border. The process however remains ad hoc. After screening, some are released and join their communities whereas others are kept in custody for further procedure. A growing number of women and children formerly associated to the groups are also returning and for the most part being allowed to re-integrate in their former communities.

Failure to address in a more systematic way the growing numbers of people in custody or surrendering, or to provide reliable, viable pathways out of the group will exacerbate the crisis by contributing to the arbitrary detention of civilians suspected of association, undermining the application of the rule of law, and reinforcing the perception that there is no way out of Boko Haram.

Moreover, the conflict has inflicted significant damages both to community services, as well as to the social bonds between groups. The return and reintegration of former Boko Haram associates must consider both of these challenges. Reintegration programmes should also include IDPs and returning refugees, the CJTF or "vigilantes" and other persons at risk of recruitment to avoid perceptions that former Boko Haram are receiving preferential treatment. Their reintegration will need to build on early recovery efforts as well as serve to promote reconciliation and social cohesion. Mainstreaming conflict prevention and peace-building in the return process will ensure that the return and reintegration process leverages the opportunities for strengthening peace and security in the process of rebuilding the Northeast.

Scope of the Consultancy

The present assignment will support the implementation of objective/output 3 of the initial phase of the Integrated Regional Stabilization of the Lake Chad Basin project funded by Germany: Reintegration of former fighters - former CJTF members/vigilantes and persons formerly associated with Boko Haram.

Under the direct supervision of the Senior Project Manager, supported by the National Experts, and in close coordination with the UNDP Global Focal Point on Reintegration based in the Bureau for Policy and Programme Support and development partners, the Consultant will carry out the following tasks:

- Support the governmental regional committee (at the Far North regional level) to draft a regional strategy on the DDR, stabilization/reintegration of elements formerly associated to Boko Haram
- Development of a draft policy for reconciliation and reintegration for Far North Region, to include consolidation of existing reintegration/community stabilization needs assessments; elaboration of an operational manual
- Production of Standard Operating Procedures (SOPs) for Community-Based Reintegration in liaise with authorities, IOM and any other actors;
- Engagement with local authorities and partner agencies to identify priorities for a joint recovery and resilience project benefiting the ex-associated Boko Haram based in Zamaï camp and in other communities throughout the region;
- Design and advise on implementation of pilot reconciliation activities in Zamaï and other relevant communities
- Support the drafting of a strategy for the transfer of vigilante committee members to municipality police
- Support fundraising, including through the development and drafting of project and funding proposal on stabilization for submission to donors

Methodology

The assignment will be carried out by the Consultant as follows:

- A desk review of all key documents
- One-on-one interviews with key informants
- Organization of workshops and focus groups discussion with relevant stakeholders
- Drafting of deliverables
- Review by the CO, UNDP/BPPS Global Reintegration Specialist and other DDR/Reintegration experts
- Strong collaboration with Nigeria CO
- Will work hand in hand with IOM to ensure complementarity with its experts in Yaounde and in Maroua.

Deliverables and timeline

The International Reintegration Consultant will be required to travel within Cameroon. If needed, she/he will be asked to travel to any other country of the lake Chad basin to liaise with UNDP staffs or other stakeholders.
