TERMS OF REFERRENCE

Shelter Rehabilitation Project in Kalaseh Neighborhood

1. BACKGROUND

Kallaseh neighborhood is one of prioritized neighborhoods in Aleppo for both WASH and SHELTER sectors, and needs support to improve living conditions and encourage people to return to their original houses.

While IDPs (Internally Displaced Persons) have begun returning to Kallaseh, they often return to homes with structural damage making them uninhabitable, in addition to posing a risk to the population safety due to the building's hazards.

Hence, UN-HABITAT has supported the Syndicate of Engineers in Aleppo to conduct detailed structural assessment targeting 48 buildings with structural damages, consisting of 55 housing units, through a selection process which took into consideration the vulnerability of targeted families and the level of damage in the targeted housing units.

This Project is the third phase of the shelter project in Kallaseh, and aims at:

Reinforcement of 32 structurally damaged buildings in Kallaseh neighborhood, in order to rehabilitate beneficiaries housing units to meet basic humanitarian living conditions.

2. OBJECTIVES

Support and strengthen stabilization in Kallaseh by improving housing conditions for returned families through rehabilitation of their damaged housing units.

3. SCOPE OF WORKS / ACTIVITIES

The purpose of this phase of the project is to reinforce 32 structurally damaged buildings. The work includes the following activities:

- Remove debris as contract items may require and/or imply in full compliance with the instructions and regulations of the relevant authorities
- Reconstruct and reinforce all damaged structural elements as per the BOQs, drawings and technical specifications
- Close all openings in external walls using durable material same as the original material
- Plastering work
- Doors for buildings main entrance and roof

4. DURATION OF WORK

Project implementation should be completed within 120 days of Project start.

5. STANDARD OF PERFORMANCE

The Contractor shall perform the required work and carry out his obligations under this Contract with all due diligence, efficiency and economy, in accordance with generally accepted techniques and practices used in performing such type of activities and with professional engineering and contracting standards recognised. He shall observe sound management, and technical engineering practices, and employ appropriate advanced technologies and safe and effective equipment, machinery, materials and methods. The Contractor shall operate and maintain the equipment and machinery involved in the implementation activities in accordance with the relevant laws, standards, regulations and legislation, as well as the requirements under the Contract, and the manuals and guidelines as provided by the manufacturers and suppliers of the

equipment and machinery.

Contractor shall execute all contract items in conformity with the technical specifications laid out in the documents and annexes of this contract, any ambiguous item of work in regard to the specification of the required materials or work, shall be resolved in light of the referral specifications and conditions of the technical committee which accepts the works.

Site Safety:

The Contractor is responsible for implementing strict safety measures on site in view of the type of works being implemented; the Contractor shall provide and erect protection items required by site conditions or as requested by the UN-HABITAT to protect persons, onsite and offsite property, as required and as supplementary to such items that have been left in place; ascertain legal and other requirements.

The Contractor shall maintain protection in place until work is complete and danger of damage has ceased; at such time as approved by UN-HABITAT, remove protections.

The contractor is solely responsible to secure the safety of the workers who are involved in the implementation of the works under this contract, and population who might be endangered as a result of implementation of the works under this contract.

The contractor shall provide safety equipment to all site basis personnel:

- Safety Helmets, Shoes, Jackets especially while working in deep excavations.
- Construction site should be closed and surrounded by warning tapes and clear signal

Contractor's Resources:

The Contractor shall utilize all necessary resources, manpower, machinery and equipment etc. in order to perform the required works in a proper, safe and timely manner. The Contractor should employ, to the maximum extent possible, the necessary labourer (skilled and/or unskilled) from within the project area.

6. MANAGEMNT MODALITIES

- 1- An engineer will be assigned by UN-Habitat to directly supervise the works of the Contractor.
- 2- The contractor shall have to obtain all required permissions from the relevant authorities prior to commencement of works.
- 3- Since all assessment and studies have been produced by the experts in the Syndicate of Engineers in Aleppo, so the Syndicate is the only technical reference for the implementation work, and in case of any ambiguity or lack of clarity in the drawings/specifications the contractor must refer that to the Syndicate in coordination with UN-HABITAT engineers.
- 4- The technical committee formed be Aleppo Governorate/Municipality will periodically monitor the work, and ensure all implemented activities meet the technical specifications.
- 5- The beneficiary family is also involved in the monitoring works, they have every right to object to the implemented work and report back to UN-HABITAT in the event of non-conformity with the specifications.
- 6- Any deviation in scope of works or quality of materials and workmanship should be agreed in advance by UN-HABITAT, the technical committee and beneficiary household.
- 7- UN-Habitat engineer shall review and accept the implemented works and release the due payments to the contractor accordingly.
- 8- After the completion of rehabilitation works, the technical committee, UN-HABITAT, the beneficiary household and the contractor should jointly visit and if the rehabilitation works ae found satisfactory, it will be handed over to the beneficiary in writing.
- 9- The awarded bidder is solely responsible to secure the commencement letter from the Municipality, the expected time needed to secure this letter must be included within the timetable submitted by the bidder. Any delays in obtaining this letter will not be taken into consideration within the contract term and the contract will not be extended for this reason.
