ATTACHMENT-1-ANSWERS TO QUESTIONS FROM PROSPECTIVE PROPOSERS

Question 1: In regard to interviews to be conducted during the preparation phase of the sectoral reports mentioned in Item D.1 of Section 5 Terms of Reference (ToR), will the total of interviews with sector representatives in 5 provinces be 40 or 10 and could you elaborate on how the key personnel will be allocated for conduct of these interviews?

Answer 1: As mentioned in item d.1 of Section 5 Terms of Reference; 10 SMEs in each sector in the aforementioned provinces (Gaziantep 4, Adana 2, Mersin 1, Kilis 1, Hatay 2) will be interviewed during that activity. Thus, in total 40 interviews (4 sectors x 10 interviews per sector) will be conducted and allocation of 10 interviews in each sector to provinces will be as Gaziantep 4, Adana 2, Mersin 1, Kilis 1, Hatay 2.

In Form G: Financial Proposal Form; it is mentioned that team leader, 5 key experts and 4 sector specialists will conduct these interviews. The Contractor will allocate key personnel time to these interviews to ensure that the activity is completed by the due date (30 days after contract signature) mentioned in Item E. "Deliverables and Schedules/Expected Outputs" of the ToR. Thus, interviews will be conducted simultaneously by different key personnel (at least 1 key personnel per interview) of the Contractor.
