Q1. A) Is it acceptable to include our global experience, or only our experience in Georgia?) Also, must the experience be from programs based on a contract, or can we include experience with grants or cooperative agreements?

A. A)Experience can be international and B) can be coming from programs based on contracts/grants/cooperative agreements as long as it's similar to the scope of work set forth in the announced RFP. However, advantage will be given to the organization with previous working experience in Georgia's municipalities.

Q2. Is there any flexibility in the timeline of the deliverables/expected outputs (Section 5, Terms of Reference, page 32 of the RFP)? Could we adjust the timing of the individual deliverables, while keeping the total project length at 15 months?

A. At the time of submitting the proposal, the deliverables/expected outputs should remain the same as in RFP. Once the winner company is selected, the timing for each deliverable/expected output is subject to negotiation with the UNDP FRLD team and will be adjusted in the service contract. Adjustment in midterm deliverables should not affect the deadline of the final deliverable and the duration of the contract should remain 15 months.
