**Question 1: Is it possible to extend the submission deadline for the subject RFP?**

**Answer 1:** *Please be informed that the submission deadline remains unchanged as 28 January 2019, 23:59 hrs. (GMT +3, Local time-Turkey) due to the time limitation imposed by project requirements.*

**Question 2: What kind of document is the power of attorney?**

**Question 3: Please further clarify the minimum requirements for the deliverable “Carbon footprint database and calculation module software”.**

- *A carbon footprint calculator for main sectors based on Microsoft Excel (or similar spreadsheet/database program) to be used by Municipality personnel.*
- *A basic module for exporting the results of the carbon footprint calculation from excel(or similar spreadsheet/database program) to the website of the Municipality. For municipality personnel, data entrance via website is not mandatory.*
- *A module embedded to website of the municipality for individual users who wants to calculate their carbon footprint.*
