I. BACKGROUND

Adopted at the conclusion of the 13th United Nations Congress on Crime Prevention and Criminal Justice, the Doha Declaration highlights the importance of supporting measures to support the rehabilitation and social reintegration of prisoners into the community. Within the framework of the Global Programme for the Implementation of the Doha Declaration and its pillar on fair, humane and effective criminal justice systems, UNODC has been working on the rehabilitation of prisoners, and

reducing the possibility of recidivism by investing in their future and changing their outlook on life. Thus, in Member States' penitentiary facilities around the globe, programmes to rehabilitate detainees, rather than merely punish them, are being implemented with the guidance and direct support of UNODC. Investments into corresponding programmes for prisoners are one of the best and most cost-effective ways of preventing their re-offending, with significant benefits not only for the individuals concerned, but also for public safety more broadly. Such educational, vocational training and work schemes programmes, including training in a variety of sectors such as crafts, construction, fashion and more positively affect prisoners' behaviour and attitude, giving them a purpose as they serve time. Moreover, they also impart viable skills and qualifications for them to apply outside of jail, enabling them to redirect their path upon liberation and secure a better future.

As part of its commitment to supporting Member States, UNODC, through the Doha Declaration Global Programme, will be supporting the Batik Work Training Programme in Lapas Perempuan Kelas IIA Semarang. While currently the prison is already conducting work training program for 30 inmates, through this support, UNODC and DGC aims to enhance the number of inmates included in the work training and improve the ecological and production sustainability of the work training activity. This will be achieved through the expansion of existing work training facility in the prison, adding additional room for the *pelorodan* and drying process, and improving the water waste removal process in the facility.

II. SCOPE OF WORK, ACTIVITIES, AND DELIVERABLES

Scope of Work

Under the direct supervision of the National Programme Officer and the overall guidance of the Country Manager, the consultant will:

- Conduct viability assessment of the proposed refurbishment and expansion proposal from the Semarang Women's Prison
- Develop initial concept design and construction budget for the refurbishment and expansion of existing work training space in Semarang Women's Prison
- Develop the second draft concept design and construction budget for the refurbishment and construction of new structure for the the work training space in Bulu Women's Prison
- Develop the final concept design and construction budget for the refurbishment and construction of new structure for the work training space in Bulu Women's Prison
- Review the technical proposal from applicants (construction vendors)
- Monitor the refurbishment and construction process.

III. WORKING ARRANGEMENTS

Institutional Arrangement

During the consultancy, the consultant is expected to coordinate closely and liaise with key counterparts (DGC Headquarter, Semarang Women's Prison, and other government stakeholder)
