Ms. Tamar Kitiashvili, UNDP, introduced the project to the audience and discussed the Terms of Reference in detail: the new VET reform has challenged the system and introduced new functions – would it be better to add those functions to the existing agencies or reorganize the system? How will the functions be accommodated? Ms. Kitiashvili emphasized the importance of budget analysis – can the current state budget be used more efficiently? Is there space for PPP?

The role of the private sector is weak, how can we strengthen it? UNDP is requesting for proposals regarding the development of new models which will tackle those topics. She also added that there will be no involvement in the operations of MoESCS agencies. The companies are encouraged to focus on the sector of agriculture when designing models.

- 1. Can several companies merge their experience and apply as one consortium? No, they can't.
- 2. Can an international holding apply?

Yes, it can.

- 3. Can two individuals combine their experience to meet the minimum requirements? No, they can't.
- 4. What is the formula to calculate the financial offer score?

Lowest Price Offer/Your Company's Offer X 300 = Your Score in Financial Offer
