2. Project Description

The Cambodia Climate Change Alliance (CCCA) - Phase 2 is an initiative led by the Ministry of Environment and supported by the European Union, Sweden and UNDP. The overall objective is to strengthen national systems and capacities to support the coordination and implementation of Cambodia's climate change response, contributing to a greener, low carbon, climate-resilient, equitable, sustainable and knowledge-based society.

CCCA operates a grant facility funding climate change adaptation and mitigation projects in the field. Window 1 of the grant facility provides support to demonstration projects implemented by Government agencies in line with their Climate Change Action Plans (CCAP), while Window 3 funds innovative projects from both civil society and the private sector. A total of USD 4.45 million have been allocated to 22 projects between 2015 and 2019 (14 under Window 1 and 8 under window 3). Projects cover a wide range of activities and sectors. As the current phase of CCCA is due to end in June 2019 and most projects in the field will be closed by March 2019, CCCA is now looking to hire an experienced consultant to extract key lessons learnt from the projects and document their impact on beneficiaries, through the development of knowledge products.

3. Objectives of the Assignment

The overall objective of the assignment is to document lessons learnt from the CCCA project portfolio, as well as individual beneficiary stories, for communication purposes and advocacy with decision-makers.

Specific objectives:

- To identify and document lessons learnt of a cross-cutting nature across the CCCA project portfolio, related to adaptation or mitigation policies or to implementation issues. These selected lessons learnt shall reflect factors of success but also common constraints and limiting factors faced by the projects;
- To identify specific innovative approaches or technologies with potential for replication and document them through case studies and beneficiary stories.

4. Scope of Work

This assignment will cover the 22 projects funded by CCCA, with activities implemented in 46 districts of Cambodia.

The proposed tasks – to be refined at inception stage – are as follows:

- Initial desk review of the project documents, progress reports and key deliverables;
- Based on the desk review and discussion with CCCA staff (in particular the Grants Management Officer) identification of a sample of projects and sites for field visits;
- Development of a brief inception report including proposed themes / areas of interest (at least three) for the lessons learnt document, potential case studies and beneficiary stories, and a refined methodology and work plan. Selected themes and case studies/stories shall reflect a diversity of interventions and beneficiaries;
- Field visits to the concerned projects including collection of the relevant data, interviews and photos;
- Collection of complementary information (as required) from concerned project teams (in Phnom Penh);
- Drafting of the knowledge products;
- Integration of comments from CCCA and finalization of the knowledge products.

The lessons learnt documents shall be structured around themes that are common across several CCCA projects (at least three). Expected length is 8,000 to 10,000 words.

Case studies shall be 2,000 to 2,500 words, with related photos.

Beneficiary stories shall be 500-800 words, with related photos.

CCCA will provide the branded templates and style guides for these knowledge products.

7. Duty Station

The duty station for this assignment is home country and Cambodia. During the assignment the consultant is expected to be based in Phnom Penh (one in country mission) with travel to selected provinces (field visits). It is estimated that the consultant needs to spend a minimum of 5 days in Phnom Penh and another 15 working days traveling to selected provinces. The project team will arrange the transportation and necessary logistics support for the travels in Phnom Penh and to provinces.

The selected individual contractor who is expected to travel to the Country Office (CO) to undertake the assignment in the country (Cambodia) is required to undertake the BSAFE training (https://trip.dss.un.org/dssweb/bsafe.aspx) prior to travelling.

8. Team

This is an individual assignment. The CCCA Grant Management Officer will support the consultant to gather relevant documents and organize/ accompany the consultant on field trips.

The consultant will report to the CCCA Trust Fund Administrator, with overall guidance from the CCCA Project Manager / Director of the Department of Climate Change.

9. Institutional Arrangement

The CCCA team will work closely with the consultant to facilitate the process, including providing relevant documents related to the projects for desk review, identifying stakeholders and sources of information, and assisting in arranging field visits. Transportation for field trips will be provided by CCCA.
