A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared. The price proposal will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical component.

The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR).

Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e.  $Sf = 1000 \times Fm / F$ , in which Sf is the financial score, Fm is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%. Submission obtaining the highest weighted points (technical points + financial points) will be selected. Interview with the candidates may be held if deemed necessary.

# *II.* BACKGROUND / PROJECT DESCRIPTION

As outlined in the Paradigm Shift Objectives and Impacts section of the project proposal, the project is designed "to contribute to increased climate-resilient sustainable development though employing an integrated approach to ensure more climate resilient homes, strengthen natural defences through the regeneration of mangroves and improve planning through the integration of climate risk information."

The project aims to rebuild 4,000 houses and to regenerate 4,000 hectares of mangroves. It also aims to increase the quality and accessibility of climate risk related information and therefore increase its utility in decision making.

The project proposal and log frame in the project proposal serves as the base of the project evaluation framework. It clearly outlines the three outcome level results expected of the project, as well as indicators that can be used to measure them:

- 1. **Increased resilience of infrastructure and the built environment to climate change** (Indicator: Number and value of physical assets made more resilient to climate change variability and change considering human benefits)
- 2. Improved management of land or forest areas contributing to emissions reductions (Indicator: Hectares of land or forests under improved and effective management that contributes to CO2 emission reductions)
- 3. Increased generation and use of climate information in decision making (Indicator: Use of climate information products/ services in decision making in climate sensitive sectors)

As part of project development an environmental and social safeguards screening was conducted. During mangrove planting, it will be necessary to undertake earth works to re-stabilize areas where aquaculture facilities have been established. The earth works will move sediment that, if not properly contained, may enter the marine environment. To ensure that the sediment is not mobilized through either wind, or more specifically, through water movement, an erosion control sediment plan will be prepared. Prior to any excavation, sediments will be tested for their presence of acid sulphate soils and/or potential acid sulphate soils. If the analysis proves positive, the sediment can be treated by a range of techniques including but not limited to liming the sediment.

## III. OBJECTIVE AND SCOPE OF THE WORK

## 1. Objectives of the Assignment

The main purpose of this assignment is to support effective implementation of the Erosion Control Sediment Framework and social and safeguards adherence and monitoring for component 2 (mangroves) of the RVCC project. This includes providing technical support and oversight the implementation of a National consultant team who will conduct site planning including technical design and soil assessments in all 05 project provinces where the mangrove activities to be implemented.

## 2. Scope of Work

The selected candidate will work closely with the project team. He/She will review, and if necessary enhance the Erosion Control Sediment Framework of the project, to guide the development of site-specific erosion control plans and social and environmental plan compliance. Further, he/she review soil data and initial site-specific plans drafted in three provinces as part of the 2019-2020 workplans and guide the project team in further developing the site-specific plans.

The work aims to support effective achievement of the activities in component 2 as outlined in the project document and to support full and effective implantation of UNDP's social and environmental screening. He/She will review and update the soil erosion framework as required by the GCF in collaboration with the national consultant team.

The framework and subsequent plans must meet appropriate standards and guidelines for testing and control.

# *IV.* EXPECTED OUTPUTS AND DELIVERABLES

#### 1. Expected Outputs and Deliverables

- Develop concise workplan for assignment within 2019 output 1
- Review/ update Erosion Control Sediment Framework and develop additional checklists or easy to use monitoring by the project to promote full and effective adherence of the social and environmental safeguards and mangrove related risks associated with the project **output 2**
- Develop ToR for a national firm to conduct soil assessments in all 05 project provinces where the mangrove activities will be implemented **output 3**
- Review and provide technical inputs to enable finalisation of the three site-specific erosion control plans already developed by national experts as part of the initiation actions required for GCF implementation
- Based on existing soil data collected, guide project team in developing site-specific erosion control plans Review and support finalisation of reports produced by technical consultants for both site planning and monitoring, and provide concise text on safeguards and risk compliance for component 2 for the draft annual report **output 4**;
- In collaboration with National experts to development of related training material to support the development of site-specific erosion control plans, for sites planned for later in the project implementation **output 5**.

#### V. ARRANGEMENT

## 1. Duration of the Work

The estimated total duration of the work is 30 days from March to December 2019 with possible extension until December 2020 based on (i) satisfactory performance and (ii) project requirement, (iii) same daily consultancy rate for 2020.

The consultant will be working on a home-based arrangement and the communication with the project team and National experts will be made via email and/or skype calling.
