4	Please provide us Photograph of Wheelchairs in Line item No. 1, 2 and 3.	Pictures are not available; the announced specifications are enough and explained in detail.
5	Manual tilt wheelchairs: the availability of at least 4 seat widths refers to have these features in the same wheelchair (it means an adjustable width for each wheelchair)?	We are requesting different tilt wheelchairs with different widths (it is not a feature within the same wheelchair). The feature within the same wheelchair of adjustability is for depth.
6	Is Ex works delivery term accepted?	No
7	Is UNDP Syria the subject to which all documents have to be addressed?	Yes
8	We are interested in the supply of manual tilt wheelchairs only. Will the total number of units (30) be supplied all together in one only delivery?	Yes, we request provision of 30 wheelchairs in one delivery.
9	When the supply is expected to be done?	3 months.
10	Adjustable backrest height, Does the backrest itself need to be adjustable or can it be adjusted by back cane?	It fine either way as long as the backrest height is adjustable.
11	High pressure pneumatic wheels, what is the P.S.I?	We request the wheels to be able to withstand high pressure of no less than 90 P.S.I



If we cannot provide the ISO certificate now, is it acceptable?

The requested ISO are essential and integral part of the bid, they will be part of the evaluation and should be available by the time of evaluation which is right after closing the bid. (ISO usually are easily available for any product and should not need to be issued).

Submit Latest Audited Financial Statement (Income Statement and Balance Sheet) including Auditor's Report for the past three years [2016-2017-2018), we didn't yet achieve those numbers, is this point an essential point to participate in the tender or is a preferred point?

The requested financial capacity (annual turnover of US\$ 600,000); is considered an essential term, and one of the main evaluation criteria, accordingly; bid doesn't comply with this term will be rejected.
