No:	Question	Answers / Corrections
1	We would like to reconfirm for ITEM TRE-04-01 if the drive power indicated in Specifications is correct. With our experience, we think that with less than 9 Kw it is difficult to guarantee a good functioning of the shredder taking into account the type of waste to be treated. Please reconfirm that is not an error in the information. And also we would like to know if the waste will come in special bags for bio sanitary waste of 50 litres or which capacity in case it is not 50 lt.	The drive power indicated in the Specification are the minimum requirements (should not be less than 2 KW). The bidder is free to suggest a higher drive power. The waste will be packed in bags of different size which are autoclaved prior shredding. It can be expected that the size of the bags shrinks during autoclaving process (typically by 50%).
