Duration of the LTA: The Individual Consultants are expected to be engaged on LTA basis (framework) for a year with possible extension for additional 2 years subject to satisfactory performance.

Duration of the Contract: Individual Contract will be signed for a specific period according to UNDP Projects needs and availability of the consultant

This is not a permanent consultation. The consultant will be **ONLY** solicited by UNDP if needed based on the ranking at the end of the process and the approved daily fees.

1. BACKGROUND

Under the guidance and supervision of the Project Manager and the in-house Civil Engineer, the consultants when needed will provide technical input about civil works contracts throughout the duration of the procurement process. The Civil Engineers will provide technical assistance and advisory support services, including the review of existing documentation related to the civil works,

evaluate associated risks, assess the compliancy with construction codes and local laws related to the civil works and construction, produce, revise technical drawings, prepare, revise Bill of Quantities (BoQ) and Cost estimates and other available documentation. The Civil Engineers are expected to carry out of civil works procurement processes and thus should be fully familiar with UN/UNDP procurement rules, carry-out an assessment of construction requirements in a specific areas, assist and/or provide preliminary data for engineering design/drawings as appropriate, support preparation of the technical documentation as regard to bidding process; take part in the evaluation of the bidding and preparation of bidding evaluation Report, etc. The Civil Engineers also work in collaboration with other project engineers and puts in place appropriate quality assurance and quality control systems directed towards continuous assurance of quality during the civil works construction process and independently verifies that all works are executed according to contract specifications and requirements.

2. SCOPE OF WORK, RESPONSIBILITIES AND DELIVERABLES

The consultants will work under the overall supervision of the Project Manager and the in-house Civil Engineer and will conduct or assist in some or all the following during his/her duties:

- Structural & architectural designs of all structures, such as basements, Buildings, retaining walls, warehouses, camp layouts, septic tanks & soak pits, workshops & shades etc.
- Drafting of specifications for civil engineering works & other similar works;
- Prepare draft of BOQs and Internal cost estimate before initiating the procurement processes
- Worked on different types of construction contracts and contract management & administration;
- On-site management of contractors, supervision & project monitoring etc.;
- Track project costs and prepare reports accordingly;
- Prepare weekly and monthly reports;
- Conduct Inspection of rehabilitation works not limited to inspection of materials, equipment's to be installed;
- Check and certify substantial construction progress/ completion and the corresponding payments. Advise UNDP to withhold payment for any work which has been rejected or any work which is not in compliance with the contract documents;
- Certify/Issue certificates of Substantial Completion in coordination with UNDP and the contractor
- Review and verify/certify the payment request submitted by the contractors before submitting to payment
- Preparation of work progress reports
- Perform other duties related to civil construction works

3. REQUIREMENTS FOR EXPERIENCE AND QUALIFICATIONS

Education:

- First degree/master's degree in civil engineering or related discipline from a recognized university

Experience:

- A minimum of 5 to 7 years' experience in Civil Engineering works, with at least 3 years involvement in the procurement of civil works contracts
- Familiarity, experience with FIDIC
- Knowledge of procurement, tendering and contracting regulations, requirements of international organizations
- Knowledge and apprehension of common recognized Civil Engineering Contract Conditions
- Advanced knowledge of computers, Microsoft packages, AutoCAD

Language Requirements:

- Written and oral communication skill in English is a necessary requirement.

4. DOCUMENTS TO BE INCLUDED WHEN SUBMITTING THE PROPOSALS.

Interested individual consultants must submit the following documents/information to demonstrate their qualifications:

1. Proposal:

- (i) Explaining why they are the most suitable for the work
- (ii) Provide a brief methodology on how they will approach and conduct the work (if applicable)

- **Contracts based on daily fee**

The financial proposal will specify the daily fee. Payments are made to the Individual Consultant based on the number of days worked.

There is no need to quote for travel expenses, UNDP will cover travels expenses (Travel and DSA) if needed.

6. EVALUATION

Individual consultants will be evaluated based on the following methodologies:

Cumulative analysis

When using this weighted scoring method, the award of the contract should be made to the individual consultant whose offer has been evaluated and determined as:

- a) responsive/compliant/acceptable, and*
- b) Having received the highest score out of a pre-determined set of weighted technical and financial criteria specific to the solicitation.*

** Financial Criteria weight: 30%*
