1. Introduction	1.1	Bidders shall adhere to all the requirements of this ITB, including any amendments made in writing by UNDP. 	1.2	Any Bid submitted will be regarded as an offer by the Bidder and does not constitute or imply the acceptance of the Bid by UNDP. UNDP is under no obligation to award a contract to any Bidder as a result of this ITB.		
	1.3	UNDP reserves the right to cancel the procurement process at any stage without any liability of any kind for UNDP, upon notice to the bidders or publication of cancellation notice on UNDP website.		
	1.4	As part of the bid, it is desired that the Bidder registers at the United Nations Global Marketplace (UNGM) website ( <u>www.ungm.org</u> ). Content	10.2 Samples of items, when required as per Section 5, shall be provided within the time specified and unless otherwise specified by the Purchaser, at no expense to the UNDP. If not destroyed by testing, samples will be returned at Bidder's request and expense, unless otherwise specified.
	10.3 When applicable and required as per Section 5, the Bidder shall describe the necessary training programme available for the maintenance and operation of the equipment offered as well as the cost to the UNDP. Unless otherwise specified, such training as well as training materials shall be provided in the language of the Bid as specified in the BDS.

14. 	.4.5 A JV, Consortium or Association in presenting its track record and experience should clearly differentiate between:

	.4.6 Previous contracts completed by individual experts working privately but who are permanently or were temporarily associated with any of the member firms cannot be claimed as the experience of the JV, Consortium or Association or those of its members, but should only be claimed by the individual experts themselves in their presentation of their individual credentials
	.4.7 JV, Consortium or Associations are encouraged for high value, multi-sectoral requirements when the spectrum of expertise and resources required may not be available within one firm.
15. Only One Bid	.5.1 The Bidder (including the individual members of any Joint Venture) shall submit only one Bid, either in its own name or as part of a Joint Venture.

17. Extension of Bid Validity Period	7.1 In exceptional circumstances, prior to the expiration of the Bid validity period, UNDP may request Bidders to extend the period of validity of their Bids. The request and the responses shall be made in writing, and shall be considered integral to the Bid.
	.7.2 If the Bidder agrees to extend the validity of its Bid, it shall be done without any change to the original Bid.

17.3 The Bidder has the right to refuse to extend the validity of its Bid, in which case, the Bid shall not be further evaluated.
18.1 Bidders may request clarifications on any of the ITB documents no later than the date indicated in the BDS. Any request for clarification must be sent in writing in the manner indicated in the BDS. #### a. Project description

The project consists of the rehabilitation of Al Baajah Water Treatment Plant located in Dijla river and which supplies drinking water for Al Baajah Village of Sharqat district. The facility is used to treat raw water and make it drinkable

After water is being treated, it will be drinkable, with good quality (NTU less than 5) furthermore, water will be supplied to people 24 hours. The water treatment Plant Supplying drinkable water for 7,000 individuals.

### 2. LOCATION

The project is located in Baajah Village, Shaqat district. Salahdin Government. Coordinates UTM E 339803 / N 3935931

### 3. BUILDING/CONSTRUCTION DESCRIPTION

The construction consists of one story building, control room for operators and water treatment plant compact unit surrounded by masonry fence. The compact unit includes submersible pumps, sedimentation tanks, pressure filters, and feeding pumps with Alum and Chlorine dosing pumps.

### 4. DESCRIPTION OF THE DAMAGE

A number of parts are broke-down others have been looted, leaving the rest which are in very bad condition. The clarifiers need to be drained and cleaned, as a buildup of mud at the bottom of tank over time has resulted them n not working properly. The chemical mixers are mostly completely damaged (new will be supplied and installed) and the rest of them will need to be overhauled to become fully operational.

The power system has been looted, content of the electrical boards burnt, and supply cables are cut. The compact unit consist of many isolated building and structures, the site needs cleaning, the tanks need epoxy painting; cracked plastering within gypsum and cement plastering need to be treated and painted; the main gate is broken and should be repaired, steel doors, windows and other steel parts need oil painting and removal of rust; ceramic tiles for walls and floor tiles for kitchen and toilets need repairs and replacing; most of the mechanical items have been looted or damaged so will need replacing of Compact unit, control system, suction frame on intake part on Dijla river.

#### 5. WORKS ON BRIEF

The rehabilitation work includes civil, sanitary, electrical and mechanical works:

- a. The civil part of the works includes <u>but not limited</u> to site preparation, reinforced concrete under compact unit, suction frame for intake, painting, main steel gate, re build fence around WTP, prefab cabin used as control room for operator as indicated on the BoQ.
- b. The sanitary works includes <u>but not limited</u> to reconnect water tank, ceramic lavatory, mixer taps, and septic tank as indicated on the BoQ.
- c. The electrical works includes <u>but not limited</u> to main distribution board, sub distribution boards, circuit and power cable, ceiling fan, fluorescent fixture, switches, brackets, outdoor lighting, and electrical water boiler as indicated on the BoQ.
