5. FINANCIAL PROPOSAL

Financial Proposals shall be submitted together with the compulsory documents, in the format provided in "Letter to UNDP Confirming Interest and Availability". Any deviation from the standard text may lead to disqualification. The interested individual consultants shall submit two separate Financial Proposals, i.e. one all-inclusive proposal for the whole assignment and one proposal demonstrating the breakdown of the daily fee of the individual consultant.

6. EVALUATION

The evaluation will be based on cumulative analysis (i.e. technical qualifications and price proposal). The weight of the technical criteria is 70%; the weight of the financial proposal is 30%. Candidates who obtain a minimum of 70 pts out of a maximum 100 pts will be considered for the financial evaluation. Candidates that do not meet the minimum requirements will be disqualified.
