If the contracts are submitted the suppliers must ensure that all required details are clearly indicated in the contracts i.e. scope, quantities of items, technical specifications, contract amount, date etc. as stated in the EOI/Prequalification document. 3	Suitcase for transport and providing set up for ergonomic operation, all components interconnected and ready to operate within the suitcase. Could you please elaborate the details of the suitcase, its specification in more detail? Also, please share the qualification criteria for the subcontractors/partners for the tender.		Through the referred EOI/Prequalification Suppliers are requested to prove their qualifications and express their interest for the full scope listed. Assessment of the interested suppliers will be based on qualification criteria stipulated in the EOI document. Further, technical details of the components, as well as suitcase, will be disclosed at ITB shared to prequalified companies. Just for you reference and as stated in the EOI, suitcase should be designed and fit all listed interconnected components and allow safe transporting, ergonomic operation. As for the subcontractors, at the EOI stage it is requested only to disclose information and details (see annex 3) about your major partners responsible for particular Products/Areas of specialization. However, the same qualification requirements are applied to the main bidder or all consortium/join venture parties in case bid is submitted through such partnership.	No
