Only a Bank guarantee that is in compliance with conditions stipulated in the Form H: Form of Proposal Security may be considered. In case it covers all the conditions of the Form H, Bank Guarantee may be provided in other form.
- 3. Is it possible to be selected without providing the bank guarantee ? Please advise**  
**We can provide all the documents certifying that the company is financially stable e.g turnover, balance sheet, etc**  
Proposal without bid security(bank guarantee) in the amount indicated in the RfP will be discarded and not considered for further evaluation
