If the proposal is submitted by JV, Consortium or Association, the minimum requirement for compliance with ISO 14001 or ISO 14064 or equivalent stated in the RFP TechnicalEvaluationCriteria, Section1.Bidder'squalification,capacityandexperience should be met by all members of JV, Consortium or Association or is it sufficient to present ISO 14001 or ISO 14064 or equivalent for any member? **ISO 14001 or ISO 14064 or equivalent is the minimum requirement for the bidders, in case of JV/Consortium it is possible if only one or several members meet the minimum requirement.**

If any audited financial statements (balance sheets, including all related notes, and income statements) for the last 3 years is not available will the financial statements signed by the organization's chief accountant be acceptable. **Audited financial statements are desirable but not mandatory, thus balance sheets and income statements signed by the chief accountant will be sufficient.**

Should the Financial Proposal be exempt of VAT or not? **Yes, the proposal should be VAT exempted**

While submitting the proposals, shall the separate envelopes of the Financial and Technical Proposals be placed in one sealed outer envelope? **Yes, both Technical and Financial Proposals may be submitted in one outer envelope, however Technical and Financial Proposals should be in separate sealed envelops.**
